Business Costs and Expenses Publication

IPSA today published figures for business costs and expenses incurred by MPs in August and September 2017. This is the latest in our routine bi-monthly publication of MPs' costs and expenses. The next publication is due on 13 March 2018. You can view MPs' claims on the Your MP section of our website.

Office Premises Survey

This year we will be doing some research about the cost, type and quality of constituency office accommodation used by MPs and their staff. To help with this, we are launching a survey for you to tell us about your experiences. Your feedback will form an important part of this research and help inform future policy making. It should take around 5 minutes to complete the survey and you can take part here.

IPSA Online

The IPSA improvement programme makes it simpler and quicker for MPs and their staff to work with IPSA. The IPSA Online homepage is now live and brings all of IPSA's current systems into one place with secure sign-on provided through the user's Parliamentary Digital Service account.
