The MP Staff User Group met yesterday in Portcullis House. The topics of discussion were the ongoing staffing budget review, an update on changes to IPSA Online and planning for year-end 2019-20. As always, we are grateful to the group for their feedback and suggestions.

Following feedback from the MP Staff User Group and other channels, we are keen to help you to select the right Proxy settings for your offices. Over the next few weeks we will be writing to MPs and Proxies to confirm current arrangements and offer guidance on how to make changes.

Outside of the meeting, an MP Staff User Group member highlighted an issue regarding holiday calculations for staff members who have changed their contracted hours within IPSA Online. This issue is now being worked on by our supplier and we hope to have this resolved soon and operating for the full financial year. Annual Publication

The next scheduled publication of MPs' business costs and expenses will be on **21 November 2019**. This will include data that is only published annually, including details of the costs of staffing for each MP, and the aggregate spending on security and disability across all MPs.

Last week we emailed all MPs with details of what will be published. Please ensure you check this data. Repayments must be received by **7 November**. If you have any questions or think a correction is needed, please let us know via email at info@theipsa.org.uk by **7 November**.

Please be aware that the data sent last week is a snapshot of your expenses for 2018-19. Any repayments and adjustments made after July 2019 may not yet be included in this data. In two weeks we will send you the adjusted data.

MP Commentary

Once again, MPs will have an opportunity to include some comments of their own about their expenditure. This will be displayed alongside your aggregated data on IPSA's website. The purpose of this commentary is to add context to MPs' spending.

ICO Registration Fee

There have been changes to the Data Protection rules requiring registration and fees. From 1 April 2019, MPs are exempt from paying the fee unless you have claimed for the cost of CCTV for security purposes. Those whose fee was due on or after 1 April 2019, and who are not responsible for CCTV, are entitled to a refund if that fee was paid.




We will be writing to all MPs who have already submitted a claim or been paid for the ICO registration fee with action you now need to take.

IPSA's Chair

The Chair of the Independent Parliamentary Standards Authority, Ruth Evans, announced in July that she would be resigning in October 2019 after over three years at IPSA. Following her departure today in order to focus on other non-executive roles, the Interim Chair of IPSA will be Richard Lloyd. The responsibility for appointing a new Chair is with the Speaker's Committee of the House of Commons. They will be advertising for a new permanent Chair in due course. MPs' Staff Contracts Consultation - Confidentiality clause

We are currently holding a consultation to consider whether the wording of the confidentiality clause, in MPs' staff employment contracts, should be made clearer, following a recommendation made in Gemma White QC's <u>Bullying and Harassment of MPs' Parliamentary Staff Independent Inquiry Report</u>.

We want to ensure that we take account of views from MPs and staff before
