At the end of January, we announced that IPSA Online, our new finance, payroll and expenses system, will launch in April. We also published our guidance for the end of the financial year along with new HMRC tax rules. Electronic copies of these documents can be found on our website here. The information includes key dates on what you need to submit, and when you need to do so, if you wish payments to be made from this year's budgets, as well as details of the transition from our current systems to the new one.

Last summer we held a series of training sessions, in London and in various regions around the country, in preparation for the launch of IPSA Online. We have organised a second round of training sessions for staff who have not yet been trained and for those who are seeking refresher training. Most people have found IPSA Online intuitive and simple to use. To help you to switch to the new system, IPSA has prepared a range of support including

Consultations

IPSA is currently running two consultations on proposed changes to the Scheme of MPs' Business Costs and Expenses and to the MPs' pension scheme.

We are consulting on a number of minor, mostly technical changes to the Scheme. We expect these to be helpful to MPs, as well as enable IPSA to regulate more proportionately and cost-effectively. If the changes are agreed, they will come into effect from 1 April 2019.

We are consulting on one technical change to the MPs' pension scheme. We will announce changes to the MPs' pension scheme in Spring 2019.
