Next week, on Thursday 15 November, our annual publication of MPs' Business Costs and Expenses will take place. This data includes details of the staffing costs for each MP, and the aggregate spending on security and disability across all MPs.

Alongside annual publication we will also publish all claims processed in June and July 2018. This data has been made available to you through the IPSA Online Homepage.
