IPSA Online update

IPSA is introducing a new online payroll, HR, finance and expenses system. The launch of this has been postponed from 2 July until later in the summer. This allows us time to resolve a few outstanding but important issues with the new system. We want to give MPs and their offices the best possible experience, so we will use this delay to make sure the system works as it should and ensure that we minimise any risk of error as we move data from one system to another.

The delay means that the existing expenses system will continue to work and will not be closing this Friday, as previously announced. The timesheet cut-off for June remains Friday **15 June**, and it will be possible to make other payroll changes until then. As the current expenses system will be continue to be available, all claims must be submitted in 90 days, as usual.

Late night working

Debates are likely to run late next week. We would like to take this opportunity to remind you that the Scheme allows MPs who have been working after 10pm on parliamentary matters to claim the following:

Hotel stays

- You can claim for a hotel and use the 'Hotel Working Late After 10pm' expense code. Please make sure the date is clear.
- If, in exceptional circumstances, MPs are unable to find a hotel for £175 or less, they may claim for the total cost, provided they have evidence to show why it was not possible to find a hotel within the price limit.

Taxi travel

- You can claim for any journey to your London area home and use the 'Taxi Working Late After 10pm' expense code.
- You can claim this from the travel budget as normal. Please note that this information will be published.

MPs' Pay and Pensions

IPSA is running a consultation to review MPs' Pay and Pensions. IPSA has a statutory duty to review MPs' remuneration in the first year of each Parliament. No major changes to the 2015 determination are proposed. The consultation document sets out proposals in relation to MPs' remuneration, covering salary, pensions and the payments they receive upon losing office.
