Annual Publication

The next scheduled publication of MPs' business costs and expenses will be on **21 November 2019**. This will include data that is only published annually, including details of the costs of staffing for each MP, and the aggregate spending on security and disability across all MPs.

This morning we emailed all MPs with updated details of what will be published, following the first set of data sent in the first week of October. Please ensure you check this data. Repayments must be received by **7 November**. If you have any questions or think a correction is needed, please let us know via email at info@theipsa.org.uk by **7 November**.

This publication will also include expenses data for all claims processed using the old expenses system from March to July 2019.

MP Commentary

Once again, MPs will have an opportunity to include some comments of their own about their expenditure. This will be displayed alongside your aggregated data on IPSA's website. The purpose of this commentary is to add context to MPs' spending.

Direct Payments Report on IPSA Online

You can find details of direct payments you have made using the 'MPD Direct Payments by MP' report.

This includes details of direct payments with Banner, XMA, Trainline and any other of your direct suppliers. Additionally this will include any payments made directly such as accommodation and constituency office rental payments.

To find the report, when logged into IPSA Online:


- Click the top left 'Menu' tab

Independent Complaints and Grievance Scheme

As of 21 October 2019, the Independent Complaints and Grievance Scheme (ICGS) is open to any member of the parliamentary community, present or former, who wishes to raise concerns, seek advice or make a complaint about bullying, harassment or sexual harassment, that has occurred at any point.

This follows the publication of Dame Laura Cox's <u>independent report</u> into the bullying and harassment of House of Commons staff in which she recommended that House employees with complaints involving historical allegations could access the new ICGS.
