## GBBC Davos Member Roundtable: 2026 Global Priorities

The roundtable focused on aligning GBBC and members around top global priorities for 2026, with emphasis on **strategic policy engagement** and **member-led workstreams**.

### 2026 Priority Themes and Proposed Workstreams



#### Theme A: RegTech for compliant 24/7 markets (DeFi + TradFi convergence)

**Why it matters:** participants emphasised that 24/7 value transfer requires 24/7 compliance capabilities

**Core topics raised:**

- RegTech roles (“nodes”) in DeFi
- KYC/AML integration at scale
- Waivers / flexibility in KYC requirements (US context mentioned)
- “Compliance-by-design” as a regulatory outcome
- Digital identity linkage



#### Theme B: Custody, wallets, and market infrastructure

**Why it matters:** custody and market structure questions are becoming central to both consumer protection and market integrity, especially as tokenised assets and exchange models evolve

**Core topics raised:**

- Crypto custody taxonomy / wallet infrastructure
- Exchange architecture and account structures
- Self-custody of issued securities within European “pilot” context



#### Theme C: Capital formation, scaling, and banking access for Web3 SMEs

**Why it matters:** participants treated this as a major competitiveness issue: innovation bottlenecks aren’t only regulatory permissioning - banking (debanking) and capital access remain impediments

**Core topics raised:**

- Capital raising and scaling support
- Debanking / banking access as a systemic constraint



#### Theme D: Infrastructure concentration risk: cloud dependencies, outages, and reputational spillovers

**Why it matters:** members framed this as an ecosystem-level issue: concentrated dependencies create single points of failure, with reputational externalities for the whole industry

**Core topics raised:**

- Cloud and infrastructure concentration
- Debanking / banking access as a systemic constraint
- Decentralised infrastructure and resilience
- On-premise requirements and regulator demands
- Data portability examples
- Resilience & concentration risk
- Regulator-facing explainer
