

'Nonpartisan' B'klyn group caught playing poli-tricks

As a tax-exempt 50lc3 nonprofit, ACORN is not permitted to endorse can-didates or host political

which shares office space with ACORN. Under each candidate's name is a list of canvass-ers working in the cam-paiens.

The community organizing group is flagrantly violating tax law, much the same way ACORN's loan counselors advised a prostitute to lie and cheat the system, said Kyle Olson, editor of the blog ACORN-cacked.com.

"Local authorities should look into whether the local ACORN office—which, by the way, also houses the national ACORN CEO and chief organizer Bertha Lewis—is engaging in political activity with tax dollars, said Olson.

"The videos released over the last several days appear to display a pat-

tern of extremely ques-tionable activities and du-bious advice from morally-depraved ACORN employees in

morally-depraved ACORN employees in several cities. If this evi-dence doesn't warrant a closer look from local and federal authorities, what will?" Olson asked. ACORN insists it is not doing anything wrong be-cause the primary en-dorsements and cam-paigning are being done

cause the primary en-dorsements and cam-paigning are being done by the group's political action committee, spokes-man Scott Levenson said.

The group's political wing has backed de Bla-sio, but has made no en-dorsement in the district

Attairs.

The two nonprofits are virtually indistinguishable, said state Sen. Stephen Saland (R-Poughkeepsie).

"It is troubling that ACORN, an organization deeply entrenched in promoting political candi-dates, is receiving mem-ber items from the same ber items from the same politicians who benefit from ACORN's campaign assistance, "Saland wrote in a letter to Attorney General Andrew Cuomo. "To ignore the need for an investigation of these member items would be a gross injustice," Saland

Launches investigation as Senate votes to nix funds

The Brooklyn District Attorney's Office yesterday launched a criminal probe into ACORN, while the Senate overwhelm-ingly voted to ban federal fundingly voted to ban federal fund-ing for the nonprofit group after two New York workers were caught on video aiding a couple posing as a pimp and prostitute. A spokesman for DA Charles Hynes confirmed the investiga-tion but would not comment further.

On the Senate floor last night, in a stunning turnaround from votes earlier this year supporting ACORN, lawmakers passed a bipartisan measure, 83 to 7, to

strip its funding.

The vote opened up the first split between Sens. Charles Schumer, who sided with the majority, and Kirsten Gillimajority, and Kirsten Gilli-brand, whom Republicans im-mediately slammed for backing the organization.

In the hidden-camera sting first revealed by The Post, two employees of ACORN Hous-ing's Brooklyn office were taped giving tax advice to activists James O'Keefe and Hannah Giles, who were costumed as a

giles, who were costained as a pimp and hooker.
"Don't say that you're a prostitute thing or whatever," housing coordinator Volda Albert is heard telling Giles.

The ACORN employees also

The ACORN employees also instructed her on how to launder the ill-gotten earnings so they couldn't be traced.

"The events of last week are not isolated," fumed Republican Sen. Mike Johanns of Nebraska, who sponsored the amendment and referenced yesterday's Post exclusive on ACORN on the Senate floor. "They magnify a troubling, systemic and criminal pattern. They serve as a public window into an organization besieged by corruption, fraud and illegal activities."

Republicans blasted Gillibrand for being one of only seven senators to vote in favor of keeping ACORN's funding.

like Senator Schumer voted against ACORN, so why did Kirsten Gillibrand vote to protect them? New York's appointed senator owes every New York taxpayer a thorough explanation," said Brian Walsh, a spokesman for the Senate campaign arm

a spokesman for the Senate campaign arm. Gillibrand's office said she found the actions of certain ACORN employees "reprehen-sible" but added, "The truth resible" but added, "The truth re-mains that thousands of New York families who are facing foreclosure depend on charita-ble organizations like ACORN for assistance."

Meanwhile, The Post has learned that ACORN got at least \$436,000 in grants from state lawmakers funneled through its tax-exempt sister agency, the

tax-exempt sister agency, the New York Agency for Commu-nity Affairs.

nity Affairs.

The biggest member item, for \$175,000, came from Assembly Speaker Sheldon Silver (D-Manhattan), with another \$10,000 grant from Senate Democratic Leader John Sampson of Brook-

Leader John Sampelyn.

"Speaker Silver is very concerned about the conversation depicted in the video and has asked ACORN for a full explanation of how the incident occurred and what policies and procedures ACORN has in place to ensure that nothing like this happens again," Silver this happens again," spokesman Dan Weiller.

The tax-exempt New York ACORN Housing Company re-ported \$226,000 in grants as of last June, including \$96,000 ported \$226,000 in grants as of last June, including \$96,000 from the city Department of Finance, \$60,000 from the New York Energy Research and Development Authority and \$70,000 from federal housing lender Fannie Mae and its New York counterpart, SONYMA.

According to its most recent federal filing, the national ACORN organization got \$11 million in direct public support and government grants national

and government grants nation-wide in 2007 — a \$3 million in-crease over 2006.

An ACORN spokesman yes-terday commented on The Post's report.

"ACORN has absolutely condemned this behavior. We've put in place procedures to ensure that this doesn't happen again," said Jonathan Rosen.

Rosen said the workers were "under review" but hadn't been fired. He said that what was caught on tape was an "informal conversation" and that no one had filled out loan or tax docuhad filled out loan or tax docu-
