



## "HYROXMOX" Invitation Code Promotion (the "Promotion") Terms and Conditions

- 1. These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy, General Terms and Conditions and any other terms we may provide to you. These terms apply in addition to any such other terms, and your use of any of our products and services remains subject to such other terms.
- 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 4. To participate in the Promotion, you must:
  - (a) download the Mox app, successfully open a Mox Account and successfully apply for Mox Credit using the invitation code displayed in the table in clause 23 of these terms (the "Invitation Code") during the period displayed in the table in clause 23 of these terms (the "Promotion Period"). The Invitation Code is not case sensitive and so its letters can be entered into the Mox app in uppercase or lowercase;
  - (b) spend at least a total of the HKD amount displayed in the table in clause 23 of these terms next to the words 'Mox Credit Spend Requirement' across one, or more, Eligible Card Transaction(s) (as described clause 5 to these terms) with Mox Credit during the period from the day you opened your Mox Account and the following 45 days ("Mox Credit Spend Requirement"); and
  - (c) comply with any other requirements that we may specify in connection with the Promotion or use of the Invitation Code.
- 5. "Eligible Card Transaction(s)" are transactions for the purchase of goods and

## 「HYROXMOX」邀請碼推廣(「推廣優 惠」) 條款及細則

- 1. 本條款適用於由 Mox Bank Limited (「Mox」、「我們」) 所提供的推廣 優惠。參加本推廣優惠,即表示你同意 本條款。
- 2. 你必須一併閱讀本條款、Mox 的個人資 料收集聲明、私隱政策、一般條款及細 則,以及我們可能向你提供的任何其他 條款。除本條款外,任何該等條款亦一 併適用,而你就使用任何我們的產品及 服務仍須受該等其他條款的約束。
- 3. 本條款與我們任何其他的條款如有任何 不一致, 概以本條款為準。
- 4. 要參與本推廣優惠, 你必須:
  - (a) 於本條款第 23 條列表中顯示的期限 (「推廣期」) 内下載 Mox 應用程 式並成功使用在本條款第 22 條列表 中顯示的邀請碼 (「邀請碼」) 開立 Mox戶口及成功申請 Mox Credit。 邀請碼不區分大小寫,因此可以將其 字母以大寫或小寫形式輸入到 Mox 應用程式内;

- (a) for a transaction to be an 'Eligible Card Transaction' and contribute towards the Mox Credit Spend Requirement it does not need to have settled during the Promotion Period (i.e. it can still appear as 'pending' in the Mox app) but must have settled on or before 14 November 2022 (i.e. it must appear as 'completed' in the Mox app); and
- (b) some examples of transactions that are not Eligible Card Transaction(s) are those that are not eligible for CashBack (see clause 7.5(b) of Schedule 1 (Terms and conditions for accounts and card management) to the General Terms and Conditions) and e-wallet top-ups including, but not limited to, transactions conducted via WeChat Pay and Octopus top-ups conducted via Apple Pay.

We will refer to transaction records held by us (which are final and conclusive in case of any discrepancy) to determine whether a transaction is an 'Eligible Card Transaction'.

- 6. Subject to the eligibility requirements set out in clause 7 of these terms, you will receive the cash reward displayed in the table in clause 23 of these terms next to the words 'Mox Credit Cash Reward' (the "Mox Credit Cash Reward") from Mox within 30 days of:
  - (a) you completing the steps in clause 4 of these terms; and
  - (b) the settlement of the Eligible Card Transactions that contribute towards the Mox Credit Spend Requirement (i.e. the Eligible Card Transactions appear as 'completed' in the Mox app) per Mox's transaction records (which are final and conclusive in case of any discrepancy).
- 7. You are eligible for the Mox Credit Cash

- 5. 「**合資格卡交易**」是指由 Mox 根據其持有的交易紀錄及按其絕對酌情權而作出最終決定的購買商品和服務的交易。不受限於以上所述的情況下:
  - (a) 一項交易要成為「合資格卡交易」及 計入 Mox Credit 消費要求並不代表 該交易需在推廣期內完成結算(即交 易狀態於 Mox 應用程式可顯示為 「處理中」)但該項「合資格卡交 易」須於 2022 年 11 月 14 日或之前 已完成結算(即於 Mox 應用程式必 須顯示為「完成」);及

Reward only if:

- (a) you have never held a Mox Account in your name at any time prior to the opening of the Mox Account using the Invitation Code. You are considered to have held a Mox Account even if you haven't completed any transactions on your prior Mox Account;
- (b) you hold a valid Mox Account in your name when Mox attempts to pay the Mox Credit Cash Reward, with that Mox Account not having been suspended or closed by you or Mox or in arrears or default; and
- (c) you meet any additional requirements communicated by Mox.
- Subject to these terms, including satisfaction of any other requirements specified by Mox in connection with the Promotion or use of the Invitation Code, Mox will continue to pay you the Mox Credit Cash Reward after the Promotion Period has ended.
- 9. We may change the dates of the Promotion Period at any time in our absolute discretion. Furthermore, if there is a quota displayed in the table in clause 23 of these terms (the "Quota"), the Promotion Period will end on the earlier of the last day of the Promotion Period and the date on which the use of the Invitation Code has reached the Quota. We will not update you on the use of the Quota (if any).
- 10. You can only participate in the Promotion once. If there is a Quota, the provision of the Mox Credit Cash Reward is on a first come, first served basis and in Mox's absolute discretion.
- 11. Neither your participation in the Promotion nor your eligibility for the Mox Credit Cash Reward may be transferred or assigned to any other person or exchanged or converted into any other benefit or right.
- 12. Mox reserves the right at any time, without notice or reason and in its sole discretion,

to:

- (a) change, modify, suspend or terminate the Promotion or these terms (including the Mox Credit Cash Reward and its monetary value);
- (b) refuse to offer or distribute the Mox Credit Cash Reward to you if Mox believes your Mox Account has been opened for an improper purpose (for example, attempting to secure payment of the Mox Credit Cash Reward by closing and opening one or more Mox Accounts) or for any other reason Mox deems relevant;
- (c) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion or determine whether the Promotion can or cannot be combined with any other offer or promotion); and
- (d) determine that the Invitation Code has been used for an improper purpose and cancel your use of the Invitation Code.

Any such decision shall be conclusive and binding on you.

- 13. If you've received the Mox Credit Cash Reward and you subsequently close your Mox Account within 12 months of when you opened it, we have the right to deduct an amount equal to the total value of the Mox Credit Cash Reward from your Mox Account prior to us completing the closure of your Mox Account.
- 14. If any dispute arises in connection with the Promotion, Mox's decision is final.
- 15. To the extent permitted by laws and regulations:
  - (a) Mox, its affiliates and shareholders shall not be responsible for any loss suffered by you; and
  - (b) you shall release Mox, its affiliates and shareholders from all actions, proceedings and claims which may

be brought by or against Mox, its affiliates or shareholders,

arising from or in connection with your participation in the Promotion (including any decision not to offer or distribute you, or your failure to receive, the Mox Credit Cash Reward) or these terms, unless any such loss, action, proceeding or claim is due to Mox's, its affiliates' or shareholders' negligence, fraud or wilful default and only to the extent such loss is reasonably foreseeable and has arisen directly and solely from such negligence, fraud or wilful default.

This clause 15 continues after the termination of these terms or the expiry of the Promotion Period.

- 16. You acknowledge that the Mox Credit Cash Reward distributed to you pursuant to these terms may be subsidised by a third party (including direct or indirect shareholders of Mox) (collectively, the "Mox Business Partners"). As a result, Mox may receive benefits from the Mox Business Partners directly or indirectly in connection with the Promotion. The nature, amount and method of calculating any such benefits may be varied at any time. Mox is entitled to retain any such benefits for its own account and benefit absolutely without having to make any prior disclosure to you. Mox may also offer benefits or advantages to the Mox Business Partners in connection with the Promotion.
- 17. The Promotion does not constitute any offer, invitation or recommendation to any person to enter into any transaction.
- 18. Nothing under these terms or the Promotion will deem, imply or suggest that a person or entity is acting as an agent or representative of Mox or otherwise soliciting business on behalf of Mox.
- 19. A person who is not a party to these terms has no rights to enforce or enjoy the benefit of any of their provisions under the Contracts (Rights of Third Parties)
