

“MOXSIUC500” Invitation Code Promotion (the “Promotion”) Terms and Conditions

1. These terms apply to the Promotion offered by Mox Bank Limited (“**Mox**”, “**we**”, “**us**”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s [Personal Information Collection Statement](#), [Privacy Policy](#), [General Terms and Conditions](#) and any other terms we may provide to you. These terms apply in addition to any such other terms, and your use of our products and services remains subject to such other terms.
3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
4. To participate in the Promotion, you must:
 - (a) download the Mox app, successfully open a Mox Account using the invitation code displayed in the table in clause 21 of these terms (the “**Invitation Code**”) and apply and be approved for Mox Credit, during the period displayed in the table in clause 21 of these terms (the “**Promotion Period**”) (the Invitation Code is not case sensitive and so its letters can be entered into the Mox app in uppercase or lowercase); and
 - (b) either:
 - (i) spend at least the HKD amount displayed in the table in clause 21 of these terms next to the words ‘Mox Credit Spend Requirement’ across one, or more, Eligible Card Transaction(s) (as described below) using your Mox Credit during the period from when you opened your Mox Account and the following 30 days (the “**Mox Credit Spend Requirement**”); or
 - (ii) apply and be approved for an Instant Loan on Mox Credit of an

1. 本條款適用於由 Mox Bank Limited（「Mox」、 「我們」）所提供的推廣優惠。參加本推廣優惠，即表示你同意本條款。

(a) clause 4(b)(i) of these terms, you will receive the cash reward displayed in the table in clause 21 of these terms next to the words 'Mox Credit Cash Reward' (the "**Mox Credit Cash Reward**") from Mox within 30 days of settlement of all Eligible Card Transactions that contribute towards the Mox Credit Spend Requirement (i.e. the Eligible Card Transactions that appear as 'completed' in the Mox app as per Mox's transaction records); and

(b) clause 4(b)(ii) of these terms, you will receive the cash reward displayed in the table in clause 21 of these terms next to the words 'Instant Loan Cash Reward' (the "**Instant Loan Cash Reward**") from Mox on or before 30 November 2022.

Each of the Mox Credit Cash Reward and the Instant Loan Cash Reward will be deposited into your Mox Account.
