<ol style="list-style-type: none"><li>1. These terms apply to the Promotion offered by Mox Bank Limited (“<b>Mox</b>”, “<b>we</b>”, “<b>us</b>”). By participating in the Promotion, you agree to these terms.</li><li>2. You must read these terms along with Mox’s Personal Information Collection Statement (<a href="https://mox.com/legal-documents/privacy/#pics">https://mox.com/legal-documents/privacy/#pics</a>), Privacy Policy Statement (<a href="https://mox.com/legal-documents/privacy/">https://mox.com/legal-documents/privacy/</a>), General Terms and Conditions (<a href="https://mox.com/legal-documents/general-terms-and-conditions/">https://mox.com/legal-documents/general-terms-and-conditions/</a>) and any other terms we may provide to you. These terms apply in addition to any such other terms, and the use of your Mox Card and account(s) will remain subject to our other terms.</li><li>3. <p>The following are some examples of transactions that do not constitute Successful Purchase Transaction(s): cash withdrawals, money transfers via the Mox app and invalid, cancelled, refunded or reversed transactions. Successful Purchase Transactions do not need to have settled (ie. appear as 'completed' in the Mox app) during the 30 day period following your Mox Account opening date (ie. they can still appear as 'pending' in the Mox app).</p> <p>6.
