These terms apply to the Promotion offered by Mox Bank Limited (“Mox”, “we”, “us”). By participating in the Promotion, you agree to these terms. 2. You must read these terms along with Mox’s Personal Information Collection Statement (https://mox.com/legal-documents/privacy/#pics), Privacy Policy Statement (https://mox.com/legal-documents/privacy/) General Terms and Conditions (https://mox.com/legal-documents/general-terms-and-conditions/) and any other terms we may provide to you. These terms apply in addition to any such other terms, and the use of your Mox Card and account(s) will remain subject to our other terms. 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail. 4. The dates during which the Invitation Code (as defined below) is active for use are displayed in the table in clause 20 of these terms (the “Promotion Period”). We may change the dates of the Promotion Period at any time in our absolute discretion. The Promotion Period may depend on the number of times the Invitation Code is used to open a Mox Account (the “Quota”). Any Quota applicable to the use of the Invitation Code is displayed in the table in clause 20 of these terms. The following are some examples of transactions that do not constitute Successful Purchase Transaction(s): cash withdrawals, money transfers via the Mox app and invalid, cancelled, refunded or reversed transactions.
