

**5% CashBack Unlock Promotion (the “Promotion”) Terms and Conditions**

1. These terms apply to the Promotion offered by Mox Bank Limited (“**Mox**”, “**we**”, “**us**”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy, General Terms and Conditions (each of which can be found in the Mox app and/or our website) and any other terms we may provide to you. These terms apply in addition to any such other terms, and your use of any of our products and services remains subject to such other terms. Terms used but not defined herein have the meaning given to them in the General Terms and Conditions.

In particular, these terms must be read together with clause 7 under the Terms and conditions for accounts and card management (Schedule 1 to the General Terms and Conditions) and the Mox CashBack Table (which can be found in the Mox app and/or our website).

3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
4. To participate in the Promotion, you must be a Mox Credit customer and during the Promotion Period (as defined in clause 20 of these terms), fulfil the eligible criteria as set out in the table in clause 19 of these terms (the “**Eligible Criteria**”). We may change the dates of the Promotion Period at any time in our absolute discretion.
5. Subject to these terms, for so long as your Eligible Split Purchase (as defined in clause 20 of these terms) is active during the Promotion Period, you will enjoy the 5% CashBack Unlock (as defined in clause 20 of these terms), on any subsequent eligible Mox Credit transaction settled at a ‘CashBack Merchant’ during the Promotion Period, as each are specified as applicable to this
