

Mox 2nd Anniversary Scratch Card Promotion (the “Promotion”) Terms and Conditions

1. These terms apply to the Promotion offered by Mox Bank Limited (“**Mox**”, “**we**”, “**us**”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s [Personal Information Collection Statement](#), [Privacy Policy](#), [General Terms and Conditions](#) and any other terms we may provide to you. These terms apply in addition to any such other terms, and your use of any of our products and services remains subject to such other terms.
3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
4. The Promotion will begin on 22 September 2022 and end on 28 September 2022, or when the available stock of the Mox Scratch Cards (as defined in clause 7 of these terms) as displayed in the table in clause 23 of these terms (“**Available Stock**”) has been exhausted, whichever is earlier (the “**Promotion Period**”).

The redemption period will begin on 22 September 2022 and end on 7 October 2022 (the “**Redemption Period**”). We may change the dates of the Promotion Period and the Redemption Period at any time in our absolute discretion. The provision of a Mox Scratch Card is on a first come first served basis, while stocks last. We will not update you on the use of the Available Stock.

5. You can participate in the Promotion by completing an Eligible Transaction (as defined below) of HKD800 or more using your Mox Credit during the Promotion Period.

1. 本條款適用於由 Mox Bank Limited (「**Mox**」、「**我們**») 所提供的推廣。參加本推廣，即表示您同意本條款。
2. 您必須一併閱讀本條款、Mox 的[個人資料收集聲明](#)、[私隱政策](#)、[一般條款及細則](#)，以及我們可能向您提供的任何其他條款。除本條款外，任何該等條款亦一併適用，而你就使用任何我們的產品及服務仍須受該等其他條款的約束。
3. 本條款與我們任何其他的條款如有任何不一致，概以本條款為準。
4. 本推廣由 2022 年 9 月 22 日開始至 2022 年 9 月 28 日或當本條款第 23 條的表格中列出的 Mox 刮刮卡 (定義見本條款第 7 條) 可用庫存 (「**可用庫存**») 已耗盡時結束 (以較早者為準) (「**推廣期**»)。

兌換期由 2022 年 9 月 22 日開始至 2022 年 10 月 7 日結束 (「**兌換期**»)。Mox 可按其絕對酌情權隨時自行決定更改推廣期及兌換期。Mox 刮刮卡數量有限，先到先得，換完即止。我們不會向您更新可用庫存的使用情況。

<p>“Participant” for the purposes of the Promotion and these terms.</p> <p>6. “Eligible Transaction” are transactions for the purchase of goods and services which are determined by Mox in its absolute discretion based on transaction records held by Mox (which are final and conclusive, in case of any discrepancy). Without limiting the above, some examples of transactions that are not Eligible Transaction(s) include:</p> <p>(a) those that are not eligible for CashBack (see clause 7.5(b) of Schedule 1 to the General Terms and Conditions (Terms and conditions for accounts and card management));</p> <p>(b) e-wallet top-ups including, but not limited to, transactions conducted via WeChat Pay and Octopus top-ups via Apple Pay; and</p> <p>(c) purchase of cigarettes and charges for plastic shopping bags.</p> <p>7. Subject to these terms, each time you become a Participant during the Promotion Period, a digital scratch card for which you can receive a Mox Scratch Card Cash Reward (as defined below) (“Mox Scratch Card”) will be made available in your Mox app after your Eligible Transaction is settled.</p> <p>8. Each Mox Scratch Card has a single cash value ranging from HKD10 to HKD2,888 (the “Mox Scratch Card Cash Reward”). You can only receive up to two Mox Scratch Cards during the Promotion Period (first come first serve, while stocks last).</p> <p>9. <p>and the monetary value of any Mox Scratch Card Cash Reward);</p> <p>(b) refuse to offer or to pay, or claw back from a Participant, or cancel a Participant's ability to redeem or receive a Mox Scratch Card or Mox Scratch Card Reward for any reason Mox deems appropriate, including, but not limited to, situations where an Eligible Transaction has been refunded or reversed (in full or in part, after which the relevant Eligible Transaction is less than the amount required in clause 4 of these terms) or if Mox believes there is any illegal, fraudulent or abnormal activity on the Participant's Mox Account; and</p> <p>(c) make any decision or take any action in connection with the Promotion (including to refuse or suspend your participation in the Promotion or determine whether the Promotion can or cannot be combined with any other offer or promotion).</p> <p>Any such decision shall be conclusive and binding on you.</p> <p>14. In the circumstances where a Participant is unable to receive the Mox Scratch Card(s) after meeting all the requirements set out in these terms, solely due to a network or technical error related to the Mox app (the occurrence of such error to be solely determined by us in our absolute discretion), we may (at our absolute discretion) pay HKD10 for each Mox Scratch Card that was not received into the Participant's Mox Account. Any payment under this clause 14 will not be counted towards the maximum number of Mox Scratch Cards you can receive pursuant to these terms.</p> <p>15.
