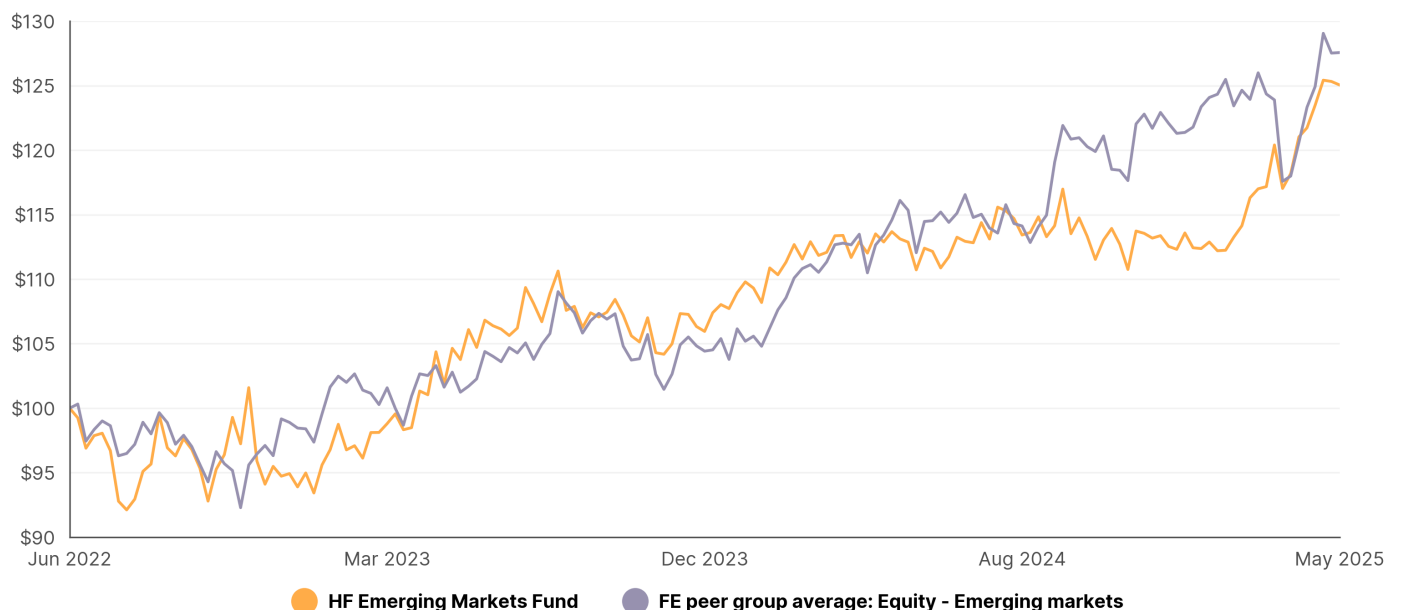

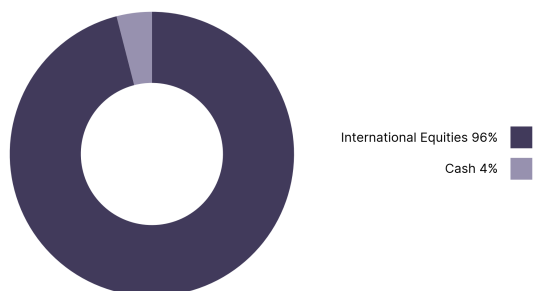

Growth of \$100 over the last 3 years^{1,2}

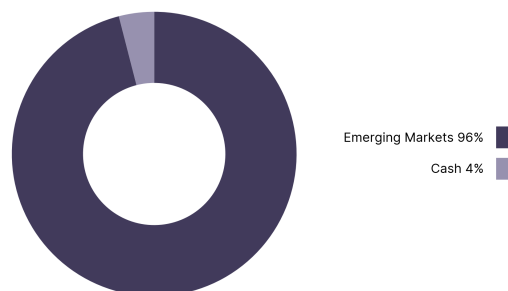

How the fund works

The Fund provides exposure to a diverse range of infrastructure securities across a number of infrastructure sub-sectors such as gas, electricity and water utilities, toll-roads, airports, rail and communication infrastructure and across geographic regions within emerging markets.

When you invest your money in the Fund, your money will be pooled together with other investors' money. We use this pool to buy investments and manage them on behalf of all investors in the Fund. This means that by investing in the Fund you have access to certain investments that you may not otherwise be able to access on your own, as well as the knowledge of the skilled underlying investment managers through which the Fund may invest. Human Financial Management Limited (HFML) retains day-to-day control over the operation of the fund.

About the manager(s)

HF outsources the management of the HF Emerging Markets Fund to ClearBridge RARE. The Emerging Markets Fund gives investors access to the high GDP growth potential of emerging markets with the more stable underlying revenue of regulated & contracted infrastructure assets.

ClearBridge RARE (RARE), the underlying manager, undertakes a benchmark unaware bottom up approach to portfolio construction and the ClearBridge RARE Emerging Markets Fund aims to provide investors with regular and stable income comprised of dividends plus capital growth through exposure to infrastructure in emerging markets.

Setting ClearBridge RARE apart from their competitors is their focus – ClearBridge RARE's business is dedicated exclusively to investing in listed infrastructure securities. ClearBridge RARE's team are first and foremost infrastructure specialists, with a unique breadth of experience across the infrastructure asset lifecycle.
