




# Growth of \$100 since inception<sup>1,2</sup>

#### How the fund works

The Fund will generally provide a diversified concentrated portfolio with exposure to a group of (no more than 15) carefully selected listed international investments. The Fund may have exposure to developed and emerging markets. The Fund will generally be unhedged but the currency hedge ratio can be varied over time.

When you invest your money in the Fund, your money will be pooled together with other investors' money. We use this pool to buy investments and manage them on behalf of all investors in the Fund. This means that by investing in the Fund you have access to certain investments that you may not otherwise be able to access on your own, as well as the knowledge of the skilled underlying investment managers through which the Fund may invest. ClearView Financial Management Limited (CFML) retains day-to-day control over the operation of the fund.

#### About the manager(s)

Aoris Investment Management is an independently owned investment boutique formed in 2017, based in Sydney, Australia. Aoris run a single investment strategy: The Aoris International Fund. The fund is highly concentrated and benchmark-unaware targeting mid to large capitalisation high-quality growth stocks. It has a return target of 8-12% p.a after fees. Aoris is currently managing AUD \$440 million.

Aoris was founded in 2017 by Stephen Arnold, following his departure from Evans and Partners where he served as Head of International Equities. Aoris is an independently owned business. It is owned by its staff and directors. Staff own 90% of the business, while 10% is held by James Carnegie, a non-executive director.
