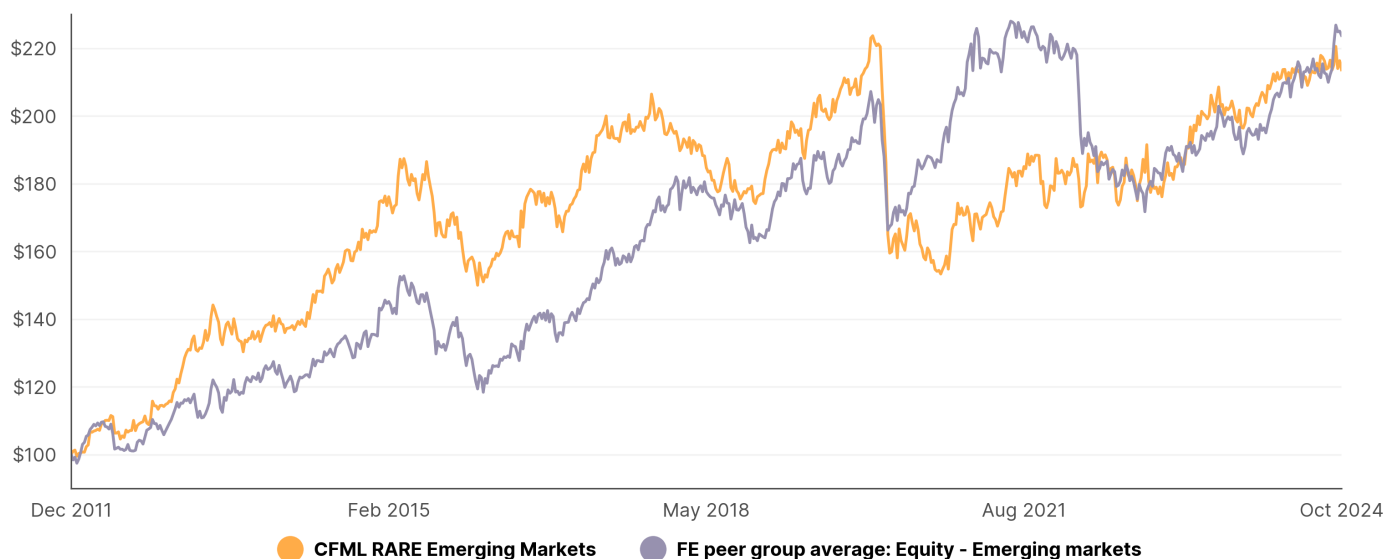

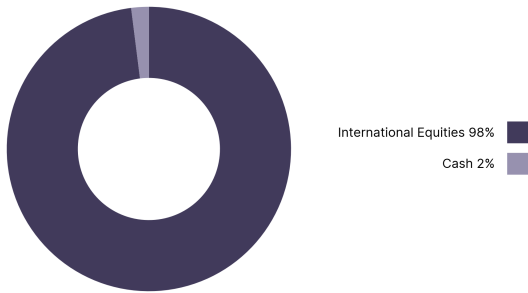

## Growth of \$100 since inception<sup>1,2</sup>

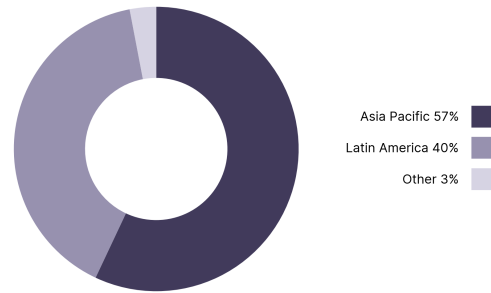
