



COVID-19 update

Keeping you prepared

Following the [State of California's announcement](#) last week for new eligibility guidelines, Blue Shield will be conducting outreach to eligible members, informing them of eligibility and encouraging vaccinations. Communications are scheduled as follows:

- April 1 [email](#) to members ages 50-64 years and not yet vaccinated.
- April 15 email to members who are 16 years and older, and not yet vaccinated.
- April 19 mailed letter to members who are 16+ and not yet vaccinated, and not on email distribution lists.

The significantly expanded number of Californians eligible for vaccination will require increased vaccine availability and administration capabilities to meet the demand. Blue Shield of California, as the state of California's third-party administrator, announced last Friday that it has reached its target for the expansion of the State's COVID-19 vaccine provider network a month ahead of schedule. California now has the capacity to administer more than four million doses a week. The increased capacity also includes a growing number of providers, local health jurisdictions, Federally Qualified Health Centers and pharmacies.

With eligibility and availability increasing dramatically this month, Blue Shield will also be increasing efforts to address vaccine hesitancy. Addressing vaccine hesitancy will become a primary focus of member engagement over the next

month.
