### President-elect Trump wins all swing states and the popular vote

Donald Trump won the US Presidential election while his Republican Party retook the Senate and may also win control of the House, creating a 'red sweep' that would solidify a unified Republican government. US equities reacted positively, as Trump's agenda includes policies that will likely boost corporate earnings via tax cuts and promote deregulation.



We reduced our equity exposure midmonth, as we believed the market was getting carried away and is not correctly pricing in potential downside risks.




### Commodities cut, gold retained

- High yield was the most resilient part of fixed income, supported by strong US economic growth and less rate sensitivity.






### Gold rose again but property was hit hard




# MAGA 2.0 – Markets Are Great Again after Trump victory

"A potentially unified Republican Congress sets the stage for President Trump to more effectively advance significant legislative changes. Market moves from here will hinge on the potential timing, size and scope of policy proposals led by tax cuts.





### Debt as % of GDP under Trump's plan




Trump's protectionist stance and preference for higher import tariffs have been well broadcasted, but the actual timeline and scale of the proposed measures are not yet clear. The actual tariffs could differ from the amounts quoted if he uses them as a negotiating tool.

• The rest of the world may continue to live in the shadow of US equities. Company and sector selection will be more important as tariffs and US exceptionalism rise. The US may remain the primary destination for capital (stronger dollar, higher yields, stronger growth).

• Trump will probably focus on trade policy as it relates to China first, given the bipartisan support for tougher relations with China. Tariffs will also be bad news for Europe and may force the ECB to cut rates faster than planned.


