<b>Global ID Check</b> (With Liveness and Biometric Feature)	Fast, digital validation of passports and other identity documents. Confirms a candidate is a real, living person matching their supplied identity documents.	Fake identities have become easier to create with AI and document editing tools. Helps identify candidates who may be using stolen or altered photos, masks, deepfakes, etc.
<b>Criminal Background Checks</b>	Varying options for criminal record screenings across county, state, federal, and country-specific checks.	Healthcare roles require high standards of trustworthiness and safety.
<b>Drug and Health Screening</b>	Flexible end-to-end selection of lab-based and rapid drug tests, physical exams, and emergency response testing.	On-the-job impairment can endanger patients and staff.
<b>License and Sanctions Checks</b>	Verification of licensure and checks for sanctions.	Many healthcare roles require specific active, valid licenses.
<b>Sanctions and Actions Monitoring</b>	Daily monitoring of employees for newly reported sanctions or disciplinary actions.	Eligibility statuses can change after hire.
<b>National Practitioner data Bank (NPDB) Check</b>	Searches for malpractice settlements and other adverse actions against healthcare providers.	Weigh past malpractice against future risk.
<b>Adult Abuse and Child Abuse Registry Checks</b>	Registry searches for confirmed abuse, neglect, or exploitation.	Vulnerable populations depend on safe caregivers.
<b>FDA Debarment List Check</b>	Verifies whether an individual is listed on the FDA Debarment List.	Healthcare employers must comply with federal standards.
<b>Occupational License and Certification Monitoring</b>	Tracks license and certification expiration dates.	Licenses can lapse, creating additional risks and liability for healthcare organizations.
<b>Verification Solutions</b>	Verifies licenses, education, training, experience, and professional reputation.	Candidate qualifications can be faked or exaggerated.
<b>Institutional Privileges and Status Verification</b>	Verifies if individuals were granted hospital privileges and their standing.	Past privilege restrictions or terminations can signal risk.
<b>Professional Liability Coverage and Malpractice History Verification</b>	Confirms coverage and identifies malpractice involvement.	Can help you protect your organization from liability exposures.
<b>Verification of Clinical References</b>	Gathers feedback from peers about clinical skills and character.	Resumes alone may not demonstrate real-world performance.
<b>DEA Controlled Substances License Verification</b>	Checks authority to prescribe controlled substances.	Prescribing without authority is a legal and a safety concern.
