Background Screening and Motor Vehicle Records (MVRs)

The HireRight and Tenstreet background check integration connects into your Tenstreet recruiting dashboard and allows for rapid, single click ordering of HireRight screening services. Services can be compiled into packages or set as ala-carte. This primary integration supports HireRight's MVR, criminal history, CDLIS+, DAC Employment History File and other background screening products.



Drug Testing and DOT Physicals

Tenstreet provides mutual customers access to HireRight's pre-employment drug screening and DOT physical services via Tenstreet's Pulse MD platform. Recruiters can order DOT or non-DOT drug screening and alcohol testing for pre-employment qualification from HireRight from within Tenstreet's Pulse MD.
