

## DOORDASH CRIMSON DEPOSIT ACCOUNT FEE SCHEDULE

Service	Description	Fee Amount
<b>Transaction Fees</b>		
Foreign Transaction Fee	Fee assessed on all purchase transactions and cash withdrawals conducted outside of the U.S. or U.S. Territories; or in a currency other than U.S. dollars. Fee is based on U.S. dollar amount of the transaction/withdrawal. When assessed, this fee will be a minimum of one cent (\$0.01). Fee as it appears on statement: <i>Foreign Transaction Fee</i>	3% of total transaction in USD
<b>ATM Fees</b>		
ATM Withdrawal Fee (Out-of-Network)	“Out-of-Network” refers to all ATMs outside of the MoneyPass® ATM Network. This is our fee assessed each time you withdraw cash from an ATM within the United States or U.S. Territories unless it displays the MoneyPass logo. You may also be charged an additional fee by the out-of-network ATM operator or network, even if you do not complete a transaction. You can withdraw cash for no fee by using an ATM displaying the MoneyPass logo. Fee as it appears on statement: <i>ATM Withdrawal Fee (OON)</i>	\$2.00
International ATM Withdrawal Fee	This is our fee each time you withdraw cash from an ATM outside the United States or U.S. Territories. You may also be charged a fee by the ATM operator or network used to complete the transaction. Transactions made outside the United States or U.S. Territories are also subject to the Card Network International Currency Conversion Fee even if they are completed in U.S. currency. Fee as it appears on statement: <i>Int'l ATM Withdrawal Fee</i>	\$2.00
<b>Service Fees</b>		
Card Replacement Fee	This is our fee for Card replacement due to lost or damaged Cards if the request is made prior to Card expiration date. Fee as it appears on statement: <i>Card Replacement Fee</i>	\$5.00
Account Closure Check Fee	Each time a check is issued to refund the balance of the Account after Account closure. Fee will not be assessed if no check is issued or if we close your Account for inactivity/dormancy or suspected fraudulent activity. Fee as it appears on statement: <i>Account Closure Check Fee</i>	\$10.00
Paper Statement Fee	This is our fee each time you request that we send you a paper statement that is not related to an unauthorized transaction within the last 120 days. A periodic statement is provided to you electronically each month at no cost. You may also view and download/print your statement history at no charge on the Mobile App <sup>1</sup> or at the Website. Fee as it appears on statement: <i>Paper Statement Fee</i>	\$2.00
<b>Potential Third-Party Fees</b>		
Cash Transfer Fee at a Retail Location	Visa ReadyLink may assess a fee for each cash transfer service at the time of the cash transfer. This is not our fee and is subject to change. Be sure to ask about the cost before conducting the cash transfer. For example, a fee of up to \$5.95 may apply when transferring cash through Visa ReadyLink locations. Go to <a href="https://visa.com/locator/readylink">visa.com/locator/readylink</a> . This information was accurate as of 07/01/2024. Avoid this fee by setting up direct deposit or sending funds via ACH to your Account.	May Vary – Up to \$5.95
ATM Surcharge Fee	Third-party ATM operators may charge a fee each time you withdraw funds or check your balance at a non-MoneyPass ATM. You may withdraw cash at no charge by using an ATM displaying the MoneyPass logo. To find a MoneyPass ATM, go to <a href="https://moneypass.com">moneypass.com</a> .	May Vary
Card Network International Currency Conversion Fee	Visa may assess a fee for currency conversion if you make a transaction in a currency other than USD. This fee is a percentage of the amount of the transaction.	May Vary
