Manage and analyze your portfolios

Equalizer allows you to **quickly run real-time analysis** including portfolio valuation, operations history, consolidation and portfolio simulation.

Views and dashboards enable you to create as many analyses as you want, responding exactly to the requirements and preferences of even the most demanding users.

Calculate performance and risk

Equalizer's ability to store very large volumes of data combined with its **processing speed allows efficient calculation** of daily TWR, average capital, IRR, volatility and other measurements at all levels: composite, customer, portfolio, asset class, sector, and individual position. It fully supports the concepts of measurement periods (breaks) and retroactive corrections (prices

and transactions).

The contribution to performance for each asset class, sector, region, rating, etc., up to individual positions, is also calculated.

Performance statistics with benchmarks can be compared, with all necessary tracking errors calculated (performance attribution).

Risk indicators and portfolio optimization are integrated through a trusted partner, providing **live risk calculation** for position analysis and embedded in the ordering process.



Manage orders and ensure compliance

All multi-asset class types of individual or global orders can be easily generated and validated through dedicated workflows, with all the appropriate checks for any restriction or constraint.

For discretionary purposes, models can be defined at different levels. Deviation reports highlight portfolios that are out of tolerance and **automatically generate portfolio adjustment orders**.

Alerts can be defined to enforce regulatory or risk constraints, and help keep your organization compliant with legal requirements.

Integration

The main data source of the PMS comes from the core banking back-office system(s) or from feeds of your depository banks and custodians.

The interface with the back-office system(s) is done using:

- Application's standard APIs for the orders,
- Standard integrator extract program for all other flows with the back-office,
- Native reconciliation between Equalizer and the back-office, data model adaptable to the data model of the back-office.

Equalizer is designed to be **integrated in real-time** with feeds from depository banks in a multi-custodian approach:

- Uses an ETL component facilitating the interface with data coming from several back-offices or any third-party system,
- Can integrate data coming from various sources regardless of content and format.

• Automatic controls at every step of the investment process, meeting all regulatory constraints for a minimized risk,

- High level of customization for the end-user and flexibility of use, thanks to various parameterization possibilities,
- User friendly and high level of autonomy for the end-user, with few IT resources needed for the system operation.

Equalizer's API is built to be integrated with third-party vendors providing real-time calculation. The system is already connected to partners (risk indicators and portfolio optimization).
