PARTICIPANTS MUST BE: (i) A SHAW CABLESYSTEMS G.P. CUSTOMER; (ii) A LEGAL RESIDENT OF CANADA (EXCLUDING QUEBEC); AND (iii) OF THE AGE OF MAJORITY, OR OLDER, IN THEIR PROVINCE OR TERRITORY OF RESIDENCE AT THE TIME OF ENTRY. CONTEST RULES

1. **CONTEST PERIOD:** The Contest Period will begin at 12:00:01 AM Mountain Standard Time ("MST") on Friday, May 1, 2020, and will end at 11:59:59 PM MST on Friday, July 31, 2020, (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.
2. **ELIGIBILITY:** To enter and be eligible to win, the entrant must be:
 - a) a Shaw customer with accounts in good standing;
 - b) a legal resident of Canada (excluding Quebec); and
 - c) of the age of majority, or older, in his/her province/territory of residence or older at the time of entry.

Employees, officers and directors of Shaw and its partners and associate companies, and each of their advertising and promotional agencies and their respective affiliates and associates, and such individual's immediate family members and persons with whom such individuals are domiciled, are not eligible to enter or participate in this Contest. For these official Contest Rules, "immediate family" refers to the father, mother, brothers, sisters, children, husband, wife or partner of such an employee, agent and/or representative. A winner of a Shaw contest within three (3) months preceding Friday, May 1, 2020 (including persons designated by such winners to take ownership of the Prize) and persons domiciled with such a winner are not eligible to enter.

All entries become the sole property of Shaw and none will be returned for any reason. Shaw shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to Shaw for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. Shaw reserves the right, in its sole discretion; to disqualify any entrant, should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

3. **ENTRY:** Maximum one (1) entry per household during the Contest Period.
4. **PRIZES:**
 - a) There are five (5) prizes of an Amazon.ca Gift Card available to be won (the "Prizes"); and
 - b) The prizes are valued at \$250 each.

5. GENERAL:

- a) On or around Monday, August 10, 2020, at approximately 10:00 AM MST five (5) random draws for each Prize will take place at Shaw's offices in Calgary, Alberta, from among all eligible entries received during the Contest Period. The first five entries drawn will be eligible to win one of the five (5) \$250 Amazon.ca Gift Cards.
 - b) The odds of being selected as a potential winner are dependent upon the number of eligible entries received by Shaw during the Contest Period.
 - c) On or around Friday, August 14, 2020, at approximately 12:00 PM MST, Shaw, acting reasonably, will attempt to contact the potential Prize winners of this Contest at the phone number indicated on the entrant's customer account between 9:00 AM MST and 5:00 PM MST for a period of five (5) business days. In the event a potential Prize winner cannot be contacted within five (5) business days after the draw or there is a return of any notification as undeliverable, he or she will be disqualified and Shaw reserves the right, in its sole discretion, to randomly select an alternate eligible entrant from among the remaining eligible entries. Upon notification, the selected entrant must respond by telephone to the contact number provided in the notification, and the selected entrant's response must be received by Shaw within two (2) business days (before 5:00 p.m. MST) of such notification. If the selected entrant does not respond in accordance with these Contest Rules, he/she will be disqualified and will not receive the Prize and another entrant may be selected in Shaw's sole discretion until such time as an entrant satisfies the terms set out herein. Shaw is not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for Shaw to receive a selected entrant's response. Proof of identification must be provided upon request.
