- 1. Testing frequency based on standard roll dimensions and one batch is approximately 180,000 lbs (or one railcar).
- 2. Machine Direction (MD) and Cross Machine Direction (XMD or TD) average values should be on the basis of 5 specimens each direction.
- 4. The colored and conductive layers may cause the carbon black content results to be higher than 3%.
- 5. Certified by core (black) formulation on geomembrane roll or molded plaque.
- 6. Modified. Samples should be taken on the core layer only.
- 7. The manufacturer has the option to select either one of the OIT methods listed to evaluate the antioxidant content in the geomembrane.
- * All values are nominal test results, except when specified as minimum or maximum.
