OFFICIAL RULES

1. **Sponsor:** Westerra Credit Union, 3700 E. Alameda Ave., Denver, CO 80209 ("Westerra Credit Union" or "Sponsor"). Sponsor presents these Official Rules ("Official Rules") for the Sweepstakes. The Prize, as defined herein, shall be provided by Westerra Credit Union.

2. **Sweepstakes Description:** By completing the digital entry form during these events: Cherry Creek Schools new educator orientation, DPS new educator orientation, Jeffco Schools new educator orientation, or the United Way Back to School Bash held during the period of August 1- 26, 2025, you agree to be entered to win a 4-pack of VIP Rockies tickets. We will draw a winner at random by September 5, 2025 and call/email them individually to help them select an eligible Rockies game.

We reserve the right to end the promotion at any time.

3. Eligibility:

(a) Individuals who attended the Cherry Creek Schools new educator orientation, DPS new educator orientation, Jeffco Schools new educator orientation, or the United Way Back to School Bash Aug 1, 2025 - Aug 26, 2025 and filled out a digital entry form during the events.

(b) The following entities or persons are disqualified from entering the Sweepstakes:

i. Any individuals (including but not limited to employees, consultants, independent contractors and interns) who have, within six months prior to August 26, 2025, held employment with or performed services for Sponsor, its parent companies, subsidiaries, affiliates, advertising, research and promotion agencies (collectively, "Sponsor Entities"); or

ii. Any organizations affiliated with the sponsorship, fulfillment, administration, prize support, advertisement or promotion of the Sweepstakes; or

iii. Any immediate family and household members of the foregoing individuals.

(c) Participation constitutes full and unconditional agreement to, and acceptance of, these Official Rules. This Sweepstakes is subject to, and all Eligible Participants shall comply with, all applicable federal, state and local laws and regulations.

4. How to Enter the Sweepstakes:

(a) By completing the digital entry form during these events: Cherry Creek Schools new educator orientation, DPS new educator orientation, Jeffco Schools new educator orientation, or the United Way Back to School Bash Aug 1, 2025 - Aug 26, 2025.

(b) Any attempted form of Entry other than as described herein is void. Entries in violation of these Official Rules will be disqualified. Any attempt by an Eligible Participant to obtain additional or fraudulent Entries will void such Entries and that Eligible Participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor reserves the right to exclude Eligible Participants for these or any other reasons, in the Sponsor's sole editorial discretion, including any violation of these Official Rules.

5. **Determination of Winners:** Sponsor shall conduct one (1) random drawing on the Date of Drawing listed below to select one (1) winner for the specific prize listed below (the "Winner") from all eligible Entries received prior to the

Deadline for Entry listed below. The Winner will only receive one Prize. In the event that there are no such Entries, there will be no drawing and the applicable prize ("Prize") will remain unawarded. The Winner(s) shall be notified via email or telephone via the contact information provided on the digital entry form. The selected Winner shall be required to respond (as directed) to the notification within seven (7) days of attempted notification date. The failure to respond timely to the notification shall result in forfeiture of the Prize and, in such case, Sponsor shall randomly select an alternate Winner from among the remaining eligible Entries. If an alternate Winner fails to respond to the notification, Sponsor shall repeat this process a maximum of three (3) times. In the event that all selected Winners for a Prize fail to respond to the notification, the applicable Prize will be forfeited. Prize Winner shall be required to verify name and complete address, unless prohibited by law. Prize Winner may also be required to provide a complete IRS Form W-9. The Prize shall not be awarded until all such information has been verified. Eligible Participants agree that Sponsor has the sole right to decide all matters and disputes arising from the Sweepstakes, and that its determinations are final and binding.

(b) Odds of winning depend on the number of Entries received prior to each Deadline for Entry. Entries received after the final Deadline for Entry will be discarded.

(c) Prize is not redeemable for cash.

7. Prize Award: If a Prize cannot be awarded for any reason, Sponsor reserves the right to substitute the Prize with another Prize of equal or greater value. The Prize is nontransferable, nonnegotiable and not redeemable for cash or merchandise. It is expressly understood that the Sponsor is under no obligation to Winner other than as expressly set forth herein. Winner is solely responsible for all federal, state and local taxes and fees associated with receipt of the Prize. Should federal, state or local law impose any tax reporting or filing obligations on Sponsor arising out of the Winner's participation in the Sweepstakes (including the Winner's receipt of and/or use of the Prize), the Winner agrees to timely provide Sponsor with any information that is reasonably needed for Sponsor to comply with any such reporting or filing obligations.

Sponsor and third parties involved in administration of the Sweepstakes or provision of the Prize ("Sweepstakes Entities") and their respective officers, directors and employees are not responsible for and shall not be liable for: (a) printing or typographical errors in any Sweepstakes-related materials and in the event of any inconsistency between Sweepstakes-related materials and these Official Rules, as these Official Rules shall govern and control, (b) technical problems or technical malfunction which may affect entering or the operation of the Sweepstakes, including electronic, hardware or software program, network, Internet or computer malfunctions, failures, or difficulties of any kind, Internet Service Provider (ISP) or other connection availability, server malfunction, failed computer, network, telephone, satellite or cable hardware or software or lines, or technical failure, or jumbled, scrambled, delayed or misdirected transmissions, computer hardware or software malfunctions, any human, mechanical or technical or electronic error, unauthorized human or nonhuman intervention of the operation of the Sweepstakes, including without limitation unauthorized tampering, hacking, theft, virus, bugs, worms or destruction of any aspect of the Sweepstakes, or loss, miscount, misdirection, inaccessibility or unavailability of an account used in connection with the Sweepstakes; or (c) any condition caused by events that may cause the Sweepstakes to be disrupted or corrupted, regardless of the reason. Sponsor is not responsible for injury or damage

to Eligible Participants' or any other person's property related to or resulting from participating in this Sweepstakes. 10. **Disputes:** Disputes, including construction, validity, interpretation and enforceability of these Official Rules shall be governed by the laws of the State of Colorado without regard to choice of law or conflict of law principles (whether of the State of Colorado or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Colorado. Any dispute, claims and causes of action arising out of or connected in any way with the Sweepstakes or the Prize awarded shall be resolved individually, without resort to any form of class action, and brought exclusively in a federal or state court in the state of Colorado. Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees. Under no circumstances will an Eligible Participant be permitted to obtain awards for, and participant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
