Gift Aid

Gift Aid is a tax relief allowing UK charities to reclaim an extra 25% on every eligible donation made by a UK taxpayer. This means Cancer Research UK can claim an extra 25p for every £1 donated, without it costing you or your sponsors an extra penny!

How to claim Gift Aid

If the donation is eligible for Gift Aid, your sponsor just needs to fill out this sponsorship form, following the guidelines at the top of the page.

What is an eligible donation?

Gift Aid can be claimed on most donations made by UK taxpayers, but there are some exceptions.

You CAN add Gift Aid to personal donations or sponsorship.

You CAN'T add Gift Aid to donations from companies, donations made on behalf of someone else, or any payment where something is given in return for the money. This might include sweepstakes, proceeds from sales or collections.
