

Miro Referral Program Terms & Conditions (General Public)

By participating in this promotion you agree to the following terms and conditions: Must be the age of majority in your jurisdiction in order to participate. Must have a valid email address to participate, as this is how you will be notified how to redeem your gift card if you qualify to receive one. Promotion available starting September 2nd, 2024, ends midnight pst October 7th 2024. Only corporate or work domain email addresses who attend Canvas '24 online on October 8, 2024 will count toward your referral total; any referral links sent to email addresses that do not have a corporate or work domain will not count towards qualifying for a gift card, neither will Miro domain addresses. Any use of bots, fake email addresses, or any other fraudulent method of boosting your number of referrals is strictly prohibited. Participants found violating these terms and conditions will be disqualified from receiving a gift card. One gift card per person. Those who qualify to receive a gift card will be notified via email no later than November 30th, 2024 of the gift card they will receive, and will need to use the link provided in the confirmation email to redeem it.
