Although Blue Ridge CTC’s ENGL 110 is not equivalent to WVU’s ENGL 101 or 102, the College of Agriculture and Natural Resources will permit students to apply these courses as the GEF 1 requirement per the WV HEPC Core Coursework Transfer Agreement. Students will be able to register for ENGL 102 at WVU to complete the GEF 1 requirement.

Although Blue Ridge CTC’s CHM 127 is not equivalent to a Chemistry course at WVU, the College of Agriculture and Natural Resources will permit students to apply this course as the GEF 2B requirement per the WV HEPC Core Coursework Transfer Agreement

For this agreement, the following course substitutions are being allowed:

- CS 1BE – AGEE 110

For this agreement, 15 hours of Agribusiness Electives from Blue Ridge CTC are being utilized to satisfy Restricted Electives within the Agribusiness Management curriculum.

ARE 491’s summer internship is one of three options available to complete the Agribusiness Management Capstone requirement. Although it is the most commonly pursued option, students may forgo this summer session and complete the requirement via study abroad or thesis

composition. Students are encouraged to work with their advisor to select the option that best suits their academic needs and interests.

The WVU General Education Foundations curriculum (GEF) includes eight areas (F1-F8). F1 (Composition and Rhetoric), F2 (Science & Technology), and F3 (Mathematics & Quantitative Skills) are specified above. These 3 Areas will be fulfilled by General Education requirements at Blue Ridge. Students must also complete 3 credit hours from each of the GEF Areas 4 through 7. GEF Area 4 will be satisfied by SOCI 203. Areas 5, 6, and 7 are slated to be taken at West Virginia University.

The WVU GEF curriculum also includes 9 credits (normally 3 three-credit courses) of Focus coursework (F8), to help students capitalize on the range and diversity of courses offered at WVU. In order to maximize connections, incorporate additional competencies, and encourage true breadth of study, students must fulfill the Focus through completion of one of the following academic paths: (a) completion of a minor; (b) completion of a double major or dual degree, or (c) completion of 9 credits of additional coursework from the list of courses approved for GEF Areas F1 through F7. Students who are following this plan of study will complete the GEF 8 requirement with successful completion of BIOL 102, CHEM 127, and CHEM 128.
