\*\*ARE 491's summer internship is one of three options available to complete the Agribusiness Management Capstone requirement. Although it is the most commonly pursued option, students may forgo this summer session and complete the requirement via study abroad or thesis composition. Students are encouraged to work with their advisor to select the option that best suits their academic needs and interests.
