

Black Friday 2024 Lottery – Conditions of Participation

§ 1 Organizer

The Organizer of this lottery is Contabo GmbH, Aschauer Straße 32a, 81549 Munich, Germany, represented by its managing directors Thomas Schimmel and Christian Böing (hereinafter referred to as the "Organizer").

§ 2 Lottery

- (1) The Organizer organizes a lottery. For this purpose, it has prepared several prizes and will distribute them to the winners in accordance with the following conditions.
- (2) The lottery will start on **November 29, 2024 at 08:00 a.m. CET** and end on **December 3, 2024 at 08:00 a.m. CET**.

§ 3 Participation

- (1) To participate in the lottery, the customer has to purchase a Contabo product within the time period between **November 29, 2024, 08:00 a.m. CET** and **December 3, 2024, 08:00 a.m. CET**. – Contabo Cloud VPS, VDS, Dedicated Servers or Object Storage. No order IDs from orders prior to the lottery can be used.
- (2) The participant has to message their order ID to Contabo (lowendtalk.com/profile/contabo_m) on LowEndTalk.
- (3) If the participant orders multiple products, they can enter (and also win) the lottery one time for each product.
- (4) Excluded from the lottery are customers who have purchased a product for the highest product line (e.g., Cloud VPS 6 or Cloud VDS XXL).

§ 4 Prize

- (1) The prize comprises the following:
 - **10** free upgrades of the purchased product to the next higher package within the same product line (e.g., Cloud VPS 1 will be upgraded to Cloud VPS 2)
- (2) The winners will be determined at random within one (1) day after the end of the lottery and will be notified via direct messages on LowEndTalk. The list of winners will also be published on LowEndTalk using their LowEndTalk nicknames.
- (3) The upgrade will be carried out automatically by our technicians. No further action from the winner is necessary.

- (4) The prize will be handed over/shipped exclusively to the winner or the legal representative. An exchange, a self-collection as well as a cash payment of the prize are not possible.
- (5) Any costs incurred for shipping the prizes will be borne by the Organizer. Any additional costs associated with claiming the prize shall be borne by the winner.

§ 5 Data protection

- (1) Participation in the lottery requires the provision of personal data. All data required in the registration such as order ID and LowEndTalk nickname of the participants will be collected and stored for the purpose of determining the prize.
- (2) The Organizer points out that all personal data of the participants will neither be passed on to third parties nor given to them for use without their consent.
- (3) All data collected will be deleted no later than 30 days after the end of the competition.
- (4) The participant is entitled to the statutory rights of information, modification and revocation within the meaning of the GDPR.

§ 6 Legal action

- (1) These conditions of participation may be amended by the Organizer at any time without separate notification.
- (2) Should any provision of the Terms and Conditions of Participation be or become invalid, this shall not affect the validity of the remaining provisions.
- (3) By taking part in the lottery, the Customer also confirms that they are aware of the Organizer's General Terms and Conditions (<https://contabo.com/en/legal/terms-and-conditions/>) and that they comply with them.
- (4) The lottery of the Organizer is exclusively subject to the law of the Federal Republic of Germany. Legal action is excluded.
