- (2) Should any provision of the Terms and Conditions of Participation be or become invalid, this shall not affect the validity of the remaining provisions.
- (3) By taking part in the campaign, the Customer also confirms that they are aware of the Organizer's General Terms and Conditions (<https://contabo.com/en/legal/terms-and-conditions/>) and that he complies with them.
- (4) The campaign of the Organizer is exclusively subject to the law of the Federal Republic of Germany. Legal action is excluded.
