2. Conditions

2.1. Guarantee

During the sales process we determine whether you qualify for this package or whether additional costs apply, for example, if additional metres of cable are required.

The installation has a warranty period of 3 years starting from the moment the installation is completed. NewMotion only provides a guarantee for work carried out by our installation and service partners. Changes or additional work carried out by another party, whether at a later stage or not, voids the guarantee for the entire installation of this charging solution. Please get in touch if you have any questions about our installations.

2.2. Conditions

The following conditions must be met to enable NewMotion's partners to carry out the installation:

- To allow the required components to be installed safely in the fuse box, we will need to temporarily switch off your electricity supply. This will last no longer than 30 minutes.
- The working area both inside and outside the house must be accessible and free of any obstacles to allow our partners to carry out the installation (this includes the fuse box and a free parking space).
- All existing components in the fuse box must have been installed according to the BS 7671 standards for electrical installations.
- An individual who is in a position to make any potential decisions about the installation or activation of the charge point must be present during the entire duration of the installation.
- There must be either:
 - A router that is connected to the Internet available within five metres of the fuse box
 - A 2G signal of at least -80dBm on the Vodafone network at the location where the charge point is to be positioned (this means roughly 3 bars of connection on a mobile phone using the 2G signal) for the Home Advanced package.

If one or more of these conditions are not met, this may result in additional costs or the cancellation or postponement of the installation. The additional costs or cancellation costs will be added to your account.
