



# COMPETITION TERMS AND CONDITIONS

## PART A- PRIZE DETAILS

<b>Winner</b>	<ul style="list-style-type: none"><li>○ 1 winner</li><li>○ The winner will be notified by email within 21 days of the closing date.</li><li>○ If a winner does not respond to MU within 14 days of the notification, MU reserves the right to select a different winner.</li><li>○ If the judges cannot agree a majority vote, so that more than one individual is tied for judges' votes, MU reserves the right to award the prize to more than one winner.</li></ul>
<b>How to enter</b>	<p>The winner will be selected from a shortlist of nominees. To nominate someone for the award, you must complete and submit a nomination form via <a href="http://www.manutd.com">www.manutd.com</a>.</p> <p>Before nominating someone for the award, you must obtain permission from that person. By submitting a nomination, you confirm that you have the nominee's permission to submit their personal details to MU as part of the nomination.</p> <p>No purchase or payment is necessary. The competition is free to enter.</p> <p>You may not submit more than one nomination in total.</p>
<b>Closing date</b>	<ul style="list-style-type: none"><li>○ The closing date for entries is 23:59 UTC on 19 June 2026.</li><li>○ No entries received after this date will be accepted.</li></ul>
<b>Eligibility</b>	<ul style="list-style-type: none"><li>○ This competition is open to individuals worldwide.</li><li>○ In order to nominate someone, you must have a Manchester United Supporter ID (provided to individuals upon the creation of an account on <a href="http://www.manutd.com">www.manutd.com</a>). The person who you nominate does not need to have a Supporter ID.</li><li>○ Employees of MU or any of its associated companies or subsidiaries (and their families) are excluded from entering the competition.</li><li>○ You must be 18 years of age to submit a nomination for this competition. If the individual you nominate is below the age of 18, you must either (i) be their parent or legal guardian; or (ii) have the consent of their parent or legal guardian. MU reserves the right to request evidence of a parent or legal guardian's consent in relation to any individual below the age of 18 who is nominated for this competition.</li></ul>
<b>Selection</b>	<ul style="list-style-type: none"><li>○ MU will review all nominations to ensure that they meet the eligibility criteria. The 5 individuals who, in the opinion of MU, have most clearly demonstrated positive impact to their local community or fan group will be shortlisted for the prize.</li><li>○ The winner will be selected from the shortlist by a panel of judges. The judges</li></ul>

will be elected members of the Manchester United Fans' Forum and Fan Advisory Board representatives. The judges will consider the following criteria when selecting a winner:

- The supporter's contribution to Manchester United, the wider fanbase, and the local community.
- The judges shall select the winner by simple majority, so the winner will be the submission selected by the majority of judges. The judges' decision will be final, and no correspondence will be entered into in relation to their decision.
- If the judges cannot agree a majority vote, so that more than one individual is tied for judges' votes, MU reserves the right to award the prize to each winner.
