Building on a pre-existing collaboration between GBIF Zimbabwe and GBIF Spain that was initiated by the GBIF Secretariat in November 2018, under the Node Mentoring Programme, the objective of this project was to strengthen GBIF Zimbabwe through node to node mentorship and capacity building of new data holders and users in Zimbabwe. The project started with online activities that resulted in the successful setting up of an IPT for GBIF Zimbabwe hosted at Bindura University of Science Education. This was followed by a hands-on training workshop held in Madrid, Spain, in September 2019. During this workshop, two members of GBIF Zimbabwe were mentored by five members of GBIF Spain in data mobilisation, citizen science and general node management. The core team of GBIF Zimbabwe's was structured in a manner similar to that of GBIF Spain. Following the training of GBIF Zimbabwe trainers, the second workshop was held at the end of January 2020 in Harare, Zimbabwe, to train data holders on various data mobilisation and publishing tools. The last workshop on data access and use, coordinated by members from GBIF Spain and GBIF Zimbabwe was held in Bindura in March 2020 and was attended by members from government departments, universities and colleges. Through online interaction between GBIF Zimbabwe and GBIF Spain, a five year Strategic Plan was developed for GBIF Zimbabwe. The plan will be the document of reference on the direction that the node will take in the next five years. Other achievements accomplished through online activities were the launching of GBIF Zimbabwe's official website and twitter account. One of the impacts of the project is that two major data holders (Forestry Commission and the National Herbarium and Botanic Garden) have registered as GBIF publishers, increasing the number of registered institutions to four. More institutions are expected to join GBIF and to publish biodiversity data through GBIF Zimbabwe's IPT.

We also struggled to transfer foreign currency to Spanish catering company that we are still trying to sort out.

Although we managed to engage a high number of stakeholders from the country in the capacity activities run during the project, we just managed to publish a few datasets from those institutions during the project period. However, we are sure that the collaborations that have been established will help us in the future mobilization of more datasets from different stakeholders and data types.

We have managed to complete the project despite this difficult time.

Project monitoring was directly done by completing the mid-term and final reports as well as the initial and final capacity self-assessments, which were prescribed in this project.

The project activities which were mainly training workshops were evaluated through evaluation forms (
https://docs.google.com/forms/d/1qwk/q2oieS74Lsq-pcXX8ybAlt5QThCmYOh6AOGRcNw/edit#responses), completed by each participant. The evaluations assessed each workshop's training content and facilitation. Evaluation of the impacts of the Data Mobilisation and the Data Access and Use workshops is still outstanding and will be done by mid June 2020. The feedback we got from the stakeholders was really good. They really appreciated both workshops on data mobilisation and data access and data use. They found the presentations and information provided really useful, like opening a new horizon for many of them. Either for the research community and the policy makers community (e.g. https://twitter.com/GbifEs/status/1235908576004145152).

Evaluation of the longer term impact of the project will be done through a survey to be conducted six to twelve months after completion of the project. Based on the results from this survey, GBIF Zimbabwe will be able to replicate these training workshops to keep on engaging national data providers, as necessary.

Going into the future, GBIF Zimbabwe will continuously monitor the quantities and qualities of data published in the GBIF database as well as data use by stakeholders in the country. The number of new GBIF Zimbabwe data publishers will also be monitored. During the course of this CESP project, two institutions were registered as data publishers in Zimbabwe. The impact of the project will also be assessed by visits to both GBIF Zimbabwe and GBIF Spain websites and activity in Twitter accounts (followers, number of tweets, number of likes and retweets). By the time of final reporting, the statistics were as follows:

GBIF Zimbabwe and GBIF Spain will continue to work together to monitor and evaluate the impact of this project which is expected within six to twelve months of completing the project. Beyond this project, GBIF Zimbabwe will continue to work with GBIF Spain, especially in critical areas that were identified during the course of this project. These include capacity building in citizen science, Living Atlases and data use software e.g. those used in ecological niche modelling and R. It is our willingness to also apply for joint proposals aimed at improving data mobilisation and use in both nodes.
