#### **Narrative Midterm report**

#### **Executive Summary**

The project has progressed satisfactorily, having already submitted the commitment of the first data set. For this process, the SIB Colombia held several advisory meetings to better structure the data flow to better visualize the collection as an information management entity. More data packages were published.

Meetings were held with two of the Partners to review their data set. The Bolivian Partner data set was reviewed, and now they are being filtered. Argentina partner data sets are not complete; the researcher is just collecting the specimens, next semester a meeting is scheduled to see their progress and/or define an alternative to fulfill their commitment.

Material from the collection continues to be selected, its assembly is carried out, and its metadata is consolidated for the subsequent publication. The training course to be taught, it was defined to do a presential course, tentative dates are between 18th and 21th October 2022.

The hiring of personnel has been carried out from the item destined for it; however, the contract was made for two people instead of one, given the limitation in the time available for this work since the designated person initially began to carry out studies of professional. More staff will be hired; Colombian government lifted the COVID restrictions, so it is possible to have more staff working actively.

Principal researcher health consequences prevented uploading the course data to reach the milestone; she could not delegate this process, no more team members attended the course. However, a team member previously trained through the lessons given by the SIB of Colombia and another course given by GBIF projects in Argentina collaborated with this process and thus corrected this debt as soon as possible.

#### Monitoring and evaluation findings

The health problems added to the principal researcher's high academic and administrative burden due to the accumulation of tasks once he left the incapacity prevented him from fulfilling these duties. The principal investigator is carrying out a sick leave procedure to minimize her workload and to have more time for project compromises.

The research group is managing permits, given that the researchers will carry out some academic activities in countries with partners. The trip to Mexico will be planned once the partner's time availability is determined.

Every month a meeting is held to review the progress of the project and aspects to be improved, likewise every week the research group has administrative meetings and in the event that there is an issue related to the project, it is addressed to provide a solution.

Last year some administrative processes slowed down, it was decided to hold the training event at the end of next semester.
