3. Overview of results

3.1. Executive summary

Give a short summary of the activities implemented and the outcomes of the project for the reporting period (500 words maximum)

This project commenced on November 1, 2017, with elaborate preparation and organization of a Stakeholders Workshop of 40 participants, awareness and encouragement to recognize the need to mobilization biodiversity data and resources. The workshop was held at the University of Liberia on January 10, 2018. Following this workshop, participants consented to share biodiversity data. About eight institutions proceeded immediately to sign data-sharing agreements with the project, while others promised to sign after authorization from their authorities.

The next phase of the project was a campaign to gather data and information from those who have signed our data-sharing agreements as well as those who promised to do so. Letters of introduction and email messages were sent to those institutions, informing them of our project technicians visit, to collect biodiversity data. So far, we have collected over 20 datasets on Liberian biodiversity. These data sets range from survey reports, independent research, and environmental impact assessments. These datasets are being collated, cleaned, and formatted for publication by the project team. Further hands-on training will be carried out in July for stakeholders (about 30 participants) and project partners on the core topics in biodiversity informatics, including, data mobilization, cleaning and formatting, publishing, and analysis for decision making.

During this mid-term period, we achieved the following deliverables: (1) completed stakeholders workshop, (2) started and making extensive progress in data collection and mobilization (3) registered two data publishing institutions (4) mobilized, cleaned and formatted 6 datasets for publication (5) fostered collaboration with SANBI, South Africa to







host Liberian biodiversity data (6) IPT account for Liberia has been set up on SANBI server, (7) participated in the two BID capacity enhancement workshops and online webinars. (8) Published six datasets on the GBIF network. We have also been soliciting technical support from the BID Secretariat and successfully submitted Early Narrative Report with three Financial Reports (FR); this report is accompanied by similar FR's.

In spite of these laudable outcomes, the projected had some setbacks as outlined below:

1. The contract for this project was signed on November 1, 2017, during the same month of general elections for president and members of legislatures in Liberia. Issues raised during the elections were not resolved in the country until late December 2017, bringing activities to a hut.

2. This stalemate in the country was further exacerbated by the inauguration of the President in January bringing to close the old order of business and transitioning a new order of business, which is taking some time to be sorted out. Most of the project collaborating institutions were affected by this transition of power. We are still awaiting signatures of communications to most of the major stakeholders from the government collaborator.

3. Funds transferred in Euros for the implementation of the project could not be easily assessed due to fiscal and monetary policies affecting banks during the transition period. This has however been resolved.

4. The project is, therefore, two months behind its original timetable.

5. The political governance cloud over the country is clearing up and there is light down the tunnel.

The data users identified in the full proposal have documented their intended use of the mobilized data and provided early feedback (<i>Midterm report</i> <i>milestone</i>)	Yes	There is extensive progress being made in Liberia in line with this activity and we are still engaging stakeholders to encourage the use of our datasets. So far one project has used our datasets to answer questions about endangered species distributions, habitat connectivity, and species vulnerability to climate change. A a research article entitled 'Reconstructing endangered mammal species distributions and forest connectivity across the humid Upper Guinea lowland rainforest of West Africa' has been submitted to the journal Biodiversity and Conservation using data from Liberia. Also, our capacity needs assessment showed that many data users identified in this project have limited capacity in analyzing biodiversity data to be used for decision making. Our just ended workshop on biodiversity data mobilizationa and usage has trained over 20 people in addressing these limitations. Cooperation among the staff of the Secretariat is excellent meeting at least twice a week to review the status of the project.
