2. Executive summary

Thanks to the Atlas of Living Australia and their powerful and adjustable platform, more and more institutions and nodes were able to install and configure basic and advanced module as data portals. For six years, we have managed to prove that the community around this platform was needed and this project will help to move from a group of nodes applying to single project calls to a more reliable community such as Linux or Apache foundation.



During the symposium organized for the SPNHC+TDWG 2018, we started a discussion that has led us to the creation of this new structure that it is now funded by the GBIF Secretariat and the LA participants. We also discussed about the creation of a technical and administrative coordinator (one position divided in two parts).

For all these reasons, we decided to divide the upcoming workshop into two parts: 3 days and half will be focused on technical components of the Living Atlases such as the spacial portal, configuring the regions tool, ALA4R, managing the Atlas's taxonomy, etc. The remaining day and a half will help us to discuss and move forward in the development and implementation of a Living Atlases Community of Practice (CoP) following the scope agreed in the Kilkenny Accord.

At the same time, we have been working on the development of the two video tutorials for the end-users of the Living Atlases. The storyboard of the first one has been validated and the company is working on the first key visual proposal. We expect to show this video during the workshop that will take place in April 2019 or at least the key visual. We also have the script of the second video ready.

We have 25 participants registered for the workshop from all around the world. We have 3 new GBIF nodes: Togo, Norway and Chile. Three new institutions: Danube University Krems from Austria, Consejo Nacional de Areas Protegidas (CONAP) from Guatemala and Vermont Center for Ecostudies from USA. All these facts prove that we need a more structured community.

To highlight their data publishers, more and more GBIF nodes or associate parties decided to implement a national data portal. Since 2013, The Atlas of Living Australia gives access to a really powerful adjustable platform. A technical community around this toolset has been created in 2013 and increased over the years.



One of the main objectives of this project is the organization of the next Living Atlases workshop, that will be held at the Muséum National d'Histoire Naturelle in Paris in April 2019. Adding to this, we will write tutorials based on exercises made during the workshops and the notes taken by the developers. Everything will be available to the public.

The other main objective is to strengthen the connexion of GBIF-mediated data by improving the exploitation of national data portals. To achieve this, we are creating videos explaining how to use different modules such as the spatial portal or the collectory. All these resources will be translated in different languages (French, Spanish, Portuguese). Additionally we will make an effort to encourage other nodes to translate videos in their own languages.

In parallel of these activities, we organized a symposium during SPNHC+TDWG conference composed of 2 sessions. The first part was a live demonstration of data portals outside Atlas of Living Australia. The second part was a discussion about the future of the Living Atlases community. This was the basis of the Kilkenny Accord that was agreed during the 25th Meeting of the GBIF Governing Board. We are currently in the process to fill two positions (technical and administrative roles).

In order to be sure that we will answer the participant needs, we will dedicate one spot for questions during the workshop. We asked the participants to give us the subject that they want to work on during the third day (link to the survey - see annex for the result).

We will also share an evaluation form among participants at the end of the workshop to provide feedbacks that will help us to organize the next workshop.

We worked on the development of the two videos. We already have the storyboard of the first video, that, we plan show it during the workshop and we also have a confirmed version of the script for second video. Once we have the video tutorials ready we plan to share them with the LA and GBIF communities via mailing lists, slack, GitHub, social networks and webpages of project partners.

The exercises made during the workshop will be available after it. We will give access to the tutorials done during past workshops to help future users to install and configure it.

Regarding the action type "Support for regional events", the organization of the workshop is being straightforward and smooth. We find easier to reach the potential participants of the workshop due to the previous capacity activities organized around the LA. Actually, we think that having 25 participants from all continents it is a good indicator of the project success. We have held several online meetings to coordinate the workshop logistics that were enough to arrange efficiently all participants' trips. GBIF Brazil has funded flight fares for 21 participants. We stayed in the budget of 15000€. Thanks to this partnership, we managed to invite institutions without financial capacities. We manage to book the hotel rooms for the GBIF participants in advance and we are below the estimated budget. We are a bit late preparing and sharing the agenda but we do not see much problem in this.



On the other hand, the documentation action type of the project is being a bit more challenging as it is a new activity for the project partners but the process is also going really well. We are happy working with the design company that fully understands the scope of the project and the goals of the videos. And despite of a slow start of the project, project partners are now being active in the process of elaborating and deciding all aspects of the videos: script, design, revising storyboards, choosing speakers, etc. We think we will manage to have the videos released by the planned dates found in the calendar.
