Executive Summary

The project has made substantial progress in the area of building human capacity for data mobilization and publication especially regarding the "Essential biodiversity Variable" and sample-based data through mentoring activities. The project continues to make progress in mobilising research-grade

sample-based data for publication via GBIF.org. Implementation of some of the project activities are, however, being hampered by the COVID-19 pandemic such that these activities have to be postponed until international travel restrictions are removed and it is safe to travel. The project team is very committed to achieving the objectives of this project, and as such, monitoring the current situation through meetings and / discussions.

Report on Activities

Activity progress summary

The project have made substantial progress with regard to the milestones attached to the mid-term report. Specifically, we have made progress as follows:

(1) Project Organised: To ensure efficient project organisation we designed a project implementation plan with assigned tasks and timelines

(https://docs.google.com/spreadsheets/d/1KaB0M38tE1i4KLvF3ZmbmcPjvYl8yKP2BpaCTe3G03o/edit#gid=0). The implementation plan provides the framework for tracking and monitoring of project activities. We organised virtual meetings to discuss progress and address risks towards achieving milestones. The project meetings have been useful in taking major decisions about impact of COVID-19 pandemic.

- (2) Mentoring Activities: The project has provided access to relevant information resources regarding the Essential Biodiversity Variable (EBVs) and Sample-based data. The project has also organised a virtual training course on the EBVs. The course took place on the 8th, 10th and 11th of March 2021 via Zoom. Prof. A. T. Peterson, University of Kansas was the resource person for the EBVs course.
- (3) Data mobilization underway and at least one sample-based data published: Data mobilization activities have been planned in the different West Africa partner countries. As such, we have been able to published one sample-based dataset (http://ipt-ghana.gbif.fr/resource?r=aburitrees). A few already mobilized datasets will also be published soon via GBIF.org. However, progress with this activity has slowed because of the COVID-19 pandemic. Data mobilization will continue to progress in West Africa among project partners but this activity will progress slowly because of the impact of COVID-19 that has brought about changes in the work schedules of people.

Unfortunately, the regional capacity enhancement workshop has to be postponed until when it is safe to resume international travel due to the COVID-19 pandemic. It is important that this course be organised in-person to accrue the maximum benefit for which reasons it was envisaged. The production of BIPs and guidelines for mainstreaming of biodiversity has also been delayed because these products / outcomes when generated will have to be tested during the regional workshop to make them more user-friendly before wider circulation. The new expected date for these activities would be sometime next year (2022) when the impact of COVID-19 is minimal and travel restrictions have removed or relax.

Report on Deliverables

Deliverables progress summary

We have a number of products / outputs from this project that are linked to the following deliverables listed in our proposal:

- (1) Efficient project management: We developed a project implementation plan and compiled notes taken during our project meetings. The project implementation plan has tasks assigned to people and timelines. The project meetings are also the forum for monitoring progress and risks associated with project implementation. Thus, these deliverables are important to assuring efficient management of the project.
- (2) Enhanced human capacity in biodiversity data mobilization and production: Adequate human capacity is important to assuring effective biodiversity data mobilization. However, there is inadequate capacity regarding mobilising biodiversity data besides occurrence data. As such, we delivered mentoring activities specifically on the EBVs and sample-based data. We provided rich information resources and delivered an online course on the EBVs.
- (3) Large volume of research-grade data records available via GBIF.org: The project continues to make progress in achieving this deliverable. More datasets will be published via GBIF.org soon. But data mobilization has slowed during to COVID-19 pandemic that have impacted work schedule.

The project will continue to find ways of delivering on the other outputs / products listed in the proposal, namely: (1) enhanced human capacity in data analysis and development of biodiversity information products (2) biodiversity information products (BIPs); and (3) guidelines for mainstreaming of biodiversity information, during and after the COVID-19 pandemic.

Monitoring and evaluation

Monitoring and evaluation findings

The monitoring and evaluation plan put in place has been very useful in the implementation of project activities. The project leader has been responsible for the overall management of the project ensuring that project activities, sharing of responsibilities, and communication within the group and with GBIFs are done successfully. The project mentors has also provided useful advice to the project leader in taking concrete decisions about the project.

The regular project meetings has been very useful in keeping partners active in the project activities. We will continue with this arrangement during the remaining project implementation period. The support received from the GBIF Secretariat especially in light of the challenges with COVID-19 pandemic was great, and the project will continue to work with the secretariat as a central part in the management and implementation of the rest project activities.

The project team continue to demonstrate unflinching support to ensure the success of this project. The team has actually expressed their interest in every aspect of the project including project reports and deliverables.

Impact of COVID-19 pandemic on project implementation

The project team unanimously agreed that there was the need for a revision of the current project work plan due to the impact of COVID-19 pandemic on the project execution. The team took this decision in light of GBIF secretariat letter on CESP 2020 projects regarding international travel in 2021, i.e., GBIF would not accept cancellation charges as eligible expenses, for international travel not already booked.

The project team therefore suggested the following changes, in light of COVID-19 pandemic, on implementation of the rest of the project activities:

- (a). Mobilization and publication of sample-based data will continue to take place in West African partner countries. However, this activity will proceed slowly due to the COVID-19 restrictions, which obviously has affected work schedules in the project partner countries.
- (b) Postponement of the capacity enhancement workshop until year next year, 2022 or until international travels can safety resume. Resumption should after vaccination and clearance for foreign travels from partners' countries from the UK and USA.
- (c) The development of draft examples of Biodiversity Information Products (BIPs) and a guidelines for mainstreaming of biodiversity information into decision-making will continue. But these deliverables will be tested, improved and finalised at the capacity enhancement workshop to be organised later in 2022.
