# VII. SECTION 41 OF INSURANCE ACT, 1938 (PROHIBITION OF REBATES)

- 1. No person shall allow or offer to allow, either directly or indirectly, as an inducement to any person to take out or continue an insurance in respect of any kind of risk relating to lives or property in India, any rebate of the whole or part of the commission payable or any rebate of premium shown on the policy, nor shall any person taking out or renewing or continuing a policy accept any rebate, except such rebate as may be allowed in accordance with the prospectus or tables of the insurers.
- 2. Any person making default in complying with the provisions of this section shall be liable for penalty which may extend to 10 lakh rupees.



#### VIII. EXCLUDED OCCUPATION CATEGORIES

The following occupation categories shall be excluded:

### Occupation

- 1. Persons involved in Professional sports teams involved in hazardous or adventurous sports, including but not limited to, para-jumping, rock climbing, mountaineering, rafting, motor racing, horse racing or scuba diving, hand gliding, sky diving, deep-sea diving
- 2. Crews of aircraft and ships
- 3. Regular Traveler via air except as a Fare paying passenger on a recognized airline operating on regular scheduled air routes or air travel by any charter aircraft duly licensed as a recognized air carrier and flown by professional crews between properly established and maintained airports/routes or enrolled into Automatic passenger covers (airlines)
- 4. Persons involved in dangerous or hazardous occupations, including but not limited to, underground mining and for contractors specializing in tunnelling, explosives, workers involved in Electrical installation with high-tension supply, Circus personnel, persons engaged in activities like racing on wheels or horseback, big game hunting, Mountaineering, winter sports, skiing, ballooning, hand gliding, river rafting, polo, Stuntman in Film and persons engaged in occupations/ activities of similar hazard etc.
- 5. Persons involved in Naval, military or air force personnel; Long Term Disability and/or Salary Continuance Business
- 6. People involved in Foreign inward business
- 7. People working under constant Electromagnetic radiations
