# To all airline customers of Sydney Airport Corporation Limited at Sydney (Kingsford Smith) Airport

#### Variation of Charges from 1 January 2022 Notice issued under clause 8 of the Sydney Airport Conditions of Use

This notice advises airlines of changes to charges to take effect from 1 January 2022. The changes are incorporated in Schedule 5 of the new version of the Sydney Airport Conditions of Use, Version 3.2, dated 1 January 2022 ("Conditions of Use") and any Sydney Airport Conditions of Use signed by Sydney Airport users.

Historically, SYD has undertaken annual security pricing adjustments and true ups. Given significant uncertainties in relation to the timing of border reopenings on traffic levels for both Domestic and International and the impact of the Government security funding mechanism (IASCR), we propose to undertake more frequent consultations in 2022. In this regard, SYD will conduct a quarterly review of International security charges and a semi-annual review of Domestic security charges to minimise risk for all parties and ensure that the security charges in 2022 best reflect actual passenger volumes and actual costs.

#### International Security Charges from 1 January 2022 to 31 March 2022

We note the introduction of the Federal Government's International Airports Security Costs Rebate (IASCR)<sup>1</sup> Scheme which is designed to meet the shortfall in costs associated with meeting mandated security obligations on International services incurred between 1 October 2021 to 31 March 2022. We do not propose to amend the current charges whilst this scheme is in operation. As such between **1 January 2022 to 31 March 2022** 

- The Passenger Charge International Services will increase by \$0.27 to \$60.69 per passenger (excluding GST) and \$66.76 (including GST); and
- The Shared Airfield Security charge applicable to non-passenger services (including freight, positioning and general aviation operations) will decrease by \$0.09 to \$0.25 per tonne (excluding GST) per aircraft movement based on maximum take-off weight (MTOW) and \$0.28 (including GST).

SYD will provide further pricing guidance in February 2022 in relation to the setting of the International Terminal Security charge and International Airfield Security Charge for the period 1 April 2022 to 30 June 2022.

#### Domestic Security Charges from 1 January 2022 to 30 June 2022

As varied under clause 8 of the Conditions of Use, from 1 January 2022 to 30 June 2022:

- The Terminal 2 Domestic Passenger Security Charge (covering passenger and checked bag screening) will decrease by \$0.95 to \$1.58 per Domestic T2 passenger (excluding GST) and \$1.74 (including GST);
- The Shared Airfield Security charge applicable to Domestic passenger service runway movements will increase by \$0.06 to \$0.23 per passenger (excluding GST) and \$0.25 (including GST); and
- The Shared Airfield Security charge applicable to non-passenger services (including freight, positioning and general aviation operations) will decrease by \$0.09 to \$0.25 per tonne (excluding GST) per aircraft movement based on maximum take-off weight (MTOW) and \$0.28 (including GST).

#### Runway charges from 1 January 2022 to 30 June 2022:

- The Passenger-based Runway Charge Domestic Services will increase by \$0.09 to \$5.65 per passenger (excluding GST) and \$6.22 (including GST) to reflect the costs of new investment works.
- The Runway Charge applicable to non-passenger services (freight) will increase by \$0.10 to \$9.67 per tonne (excluding GST) per aircraft movement based on maximum take-off weight (MTOW) and \$10.64 (including GST) to reflect the costs of new investment works.
- The Runway Charge applicable to non-passenger services (including positioning flights and general aviation operations) will increase by \$0.10 to \$6.91 per tonne (excluding GST) per aircraft movement based on maximum take-off weight (MTOW) and \$7.60 (including GST) to reflect the costs of new investment works.

These revised charges are in addition to any applicable charges already set out in Schedule 5 to the Conditions of Use or agreed separately with airlines, which are not affected by this notification. Minimum charges continue to apply as specified in Schedule 5.

#### New Investment Works

In accordance with the Conditions of Use and airline agreements, airlines have been consulted regarding variations to aeronautical charges to reflect the costs of new investment projects. Aeronautical Capital Investment Consultative Group (ACICG) documentation is available upon request. Charges for completed projects are incorporated into user charges from 1 January 2022.
