### Summary of Public Exhibition



#### Sydney Airport engaged with the community across five key pillars

#### Public Notification

- 700 key stakeholders notified on first day of exhibition
- 160,000 people notified via social media
- Quarter page advertisement on page 7 of Sydney Morning Herald
- Advertisements in 30 community newspapers
- 270,000 households around the airport received a letter box drop

# Public Display

- 24 static displays put in place at local councils and libraries
- Range of materials made available, including:
  - The two main documents
  - 16 page summary booklet
  - 9 separate fact sheets

#### Community Engagement

- 12 community information sessions held across Sydney
- Senior representatives from Sydney Airport attended
- A number of meetings held with key stakeholders, including airlines, tenants and local business groups

# Dedicated Phone Line and Email

- Dedicated 1800 community information line and email address were established
- 278 emails and
  19 calls received



### Overview of Public Submissions



#### 278 submissions received, with approximately 750 individual comments

#### Ground transport:

- Reduce the station access fee and increase public transport options
- Need to retain Alexandra cycleway

#### Aircraft noise:


- Concern about the increase in aircraft movements and the ability to implement noise sharing
- Change in ANEF contours and publication of additional noise metrics
- What Sydney Airport is doing to reduce groundbased noise

#### Environment:

- Need to address climate change impacts, air quality, PFAS
- Requests to do more to improve water quality and reduce water use

#### Other issues:

- Support for plans to integrate operations in the T2/T3 precinct
- Requests for more detail on the location and built form of proposed commercial developments
- How Western Sydney Airport will impact Sydney Airport
- Both support for, and objection to, reviewing operating restrictions (especially curfew)
- Support for growth in jobs resulting from increased aviation activity
- Importance of guaranteed access to Sydney Airport for regional airlines






## Master Plan 2039: Next Steps



- After giving due regard to each comment in the submissions, the preliminary draft Master Plan 2039 was updated to produce the draft Master Plan 2039 (dMP2039), which includes a new Five Year Environment Strategy 2019-2024
- The dMP2039 and accompanying certificates and reports have been submitted to the Deputy Prime Minister and Minister for Infrastructure, Transport and Regional Development for consideration
- Under the Airports Act 1996, the Minister is required to make a decision within 50 business days, subject to any extensions
- If approved, dMP2039 becomes the final Master Plan 2039 and Sydney Airport must notify the public and publish the final document within 50 business days after the approval





### **Community Aviation Consultation Group**



- Sydney Airport is required to establish a Community Aviation Consultation Group (CACG)
- The International Association for Public Participation (IAP2) spectrum provides guidance for governments, businesses and other organisations on ways to engage with communities
- Sydney Airport's CACG will be more collaborative in nature than any of its other existing community engagement activities
- The aim is to provide a deliberative engagement forum, with membership that is representative of the local community and which will be convened to consider, discuss and provide advice to Sydney Airport upon specific airport and aviationrelated issues.
- The CACG will not displace the work SACF undertakes, nor diminish Sydney Airport's existing engagement activities with the community and other stakeholders.

#### IAP2'S PUBLIC PARTICIPATION SPECTRUM



The IAP2 Federation has developed the Spectrum to help groups define the public's role in any public participation process. The IAP2 Spectrum is quickly becoming an international standard.

### SE Sector Apron Development Project



- The project will upgrade the existing 2 X code E aircraft bay and aims to:
  - Facilitate forecast international passenger growth
  - Improve taxi times for aircraft using parallel north-south runway
  - Provide efficient flow to and from T1 to the parallel runway
  - Improve airline on-time performance during the peak
  - Improve access to T2/T3 terminal precinct
- Ground-based power units and preconditioned air provided to enable aircraft auxiliary power units to be turned off, reducing emissions and ground-based noise
- Work on taxiways and main north-south runway will be undertaken during curfew, and will be returned to full operation following each curfew shift.
- Works impacting on east-west runway will be undertaken 24 hours a day. During airport operational periods (6am – 11pm), works will be restricted to enable runway to be recalled for noise sharing or other operational purposes as required
- Construction forecast to commence August 2019. Expected completion March 2022.



### Sydney Gateway



- Sydney Airport has been working closely with NSW Roads and Maritime concerning the Sydney Gateway project
- As part of the project will be on the airport site, the planning approvals process will involve both a statebased EIS and a Commonwealth major development plan under the *Airports Act 1996*
- Sydney Gateway will ensure:
  - direct and equal travel times to and from the T2/T3 and T1 precincts and the St Peters Interchange
  - widening of Qantas Drive to three through lanes in each direction
  - new dedicated Qantas Drive flyover entry in to the T2/T3 precinct
  - existing Airport Drive will become an internal airside/landside road
  - general traffic will continue to be able to travel toll free between the airport precincts.
- SACF will be briefed in more detail later in 2019
