



## SYDNEY AIRPORT Application Fees for Planning Approvals

The fees will vary according to the type of application (MW, SC, ST, DA, AA) being submitted.

A flat fee of \$300.00 will apply to all Minor Works (MW) Applications.

A Sydney Airport Consent (SC) or Staged Application (ST) is required for all construction works at Sydney Airport. The application fee will depend on the total estimated cost of proposed building or works of the application being submitted. To estimate the cost of proposed works, refer to the Fee Schedule table below.

A Development Application (DA) for complex projects should be submitted at the concept stage of the design, so that Sydney Airport can assess the broader impacts of the proposal on the Airport's operations and planning objectives and the applicant can have certainty to proceed with the detailed design. The DA fee is 25% of the fee set out in the Fee schedule table below or \$300.00 minimum.

The fee applicable to an Amended Application (AA) is 25% of the original application fee.
