Sydney Airport is proud of the progress we have made in increasing our overall female representation in the workforce, increasing to 36.4%. Further, it is pleasing that the percentage of females in management is consistent with our overall female representation (36.6%). While we continue to strive to improve the gender composition of our workforce, we acknowledge the many amazing women in our business who are role models for others. We actively monitor recruitment practices to enable us to attract and retain additional female talent. The growth in our female representation has been driven by a combination of fewer females leaving and more females being hired. Female manager new hires accounted for 37.7% of all manager hires and female non-manager new hires accounted for 41.3% of all non-manager hires.

As compared to last year we have seen decline in the gender remuneration ratios for men and women. Given the progress that had been made in previous years we analysed the results to better understand what was driving this decline. Firstly, the loss of a female KMP had a significant impact on the executive level ratios.

In other parts of the business we have assured ourselves that men and women are being paid the same amount for the same role.
