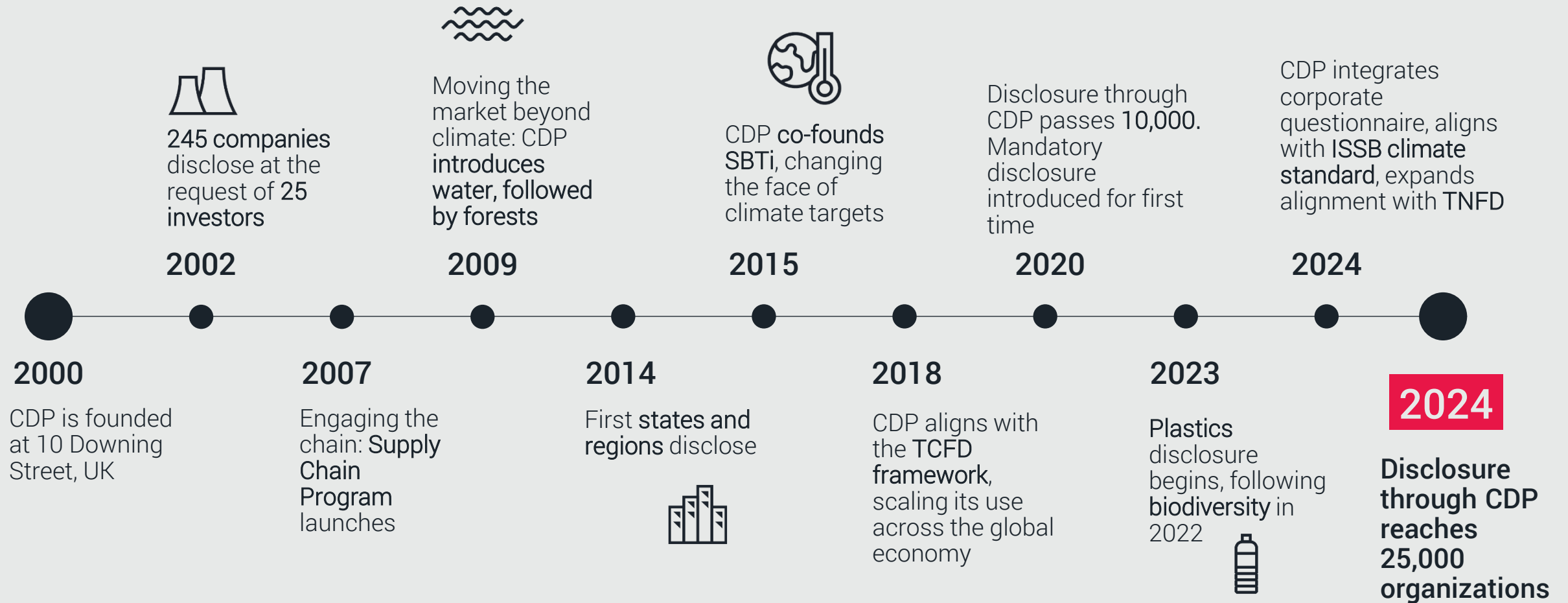

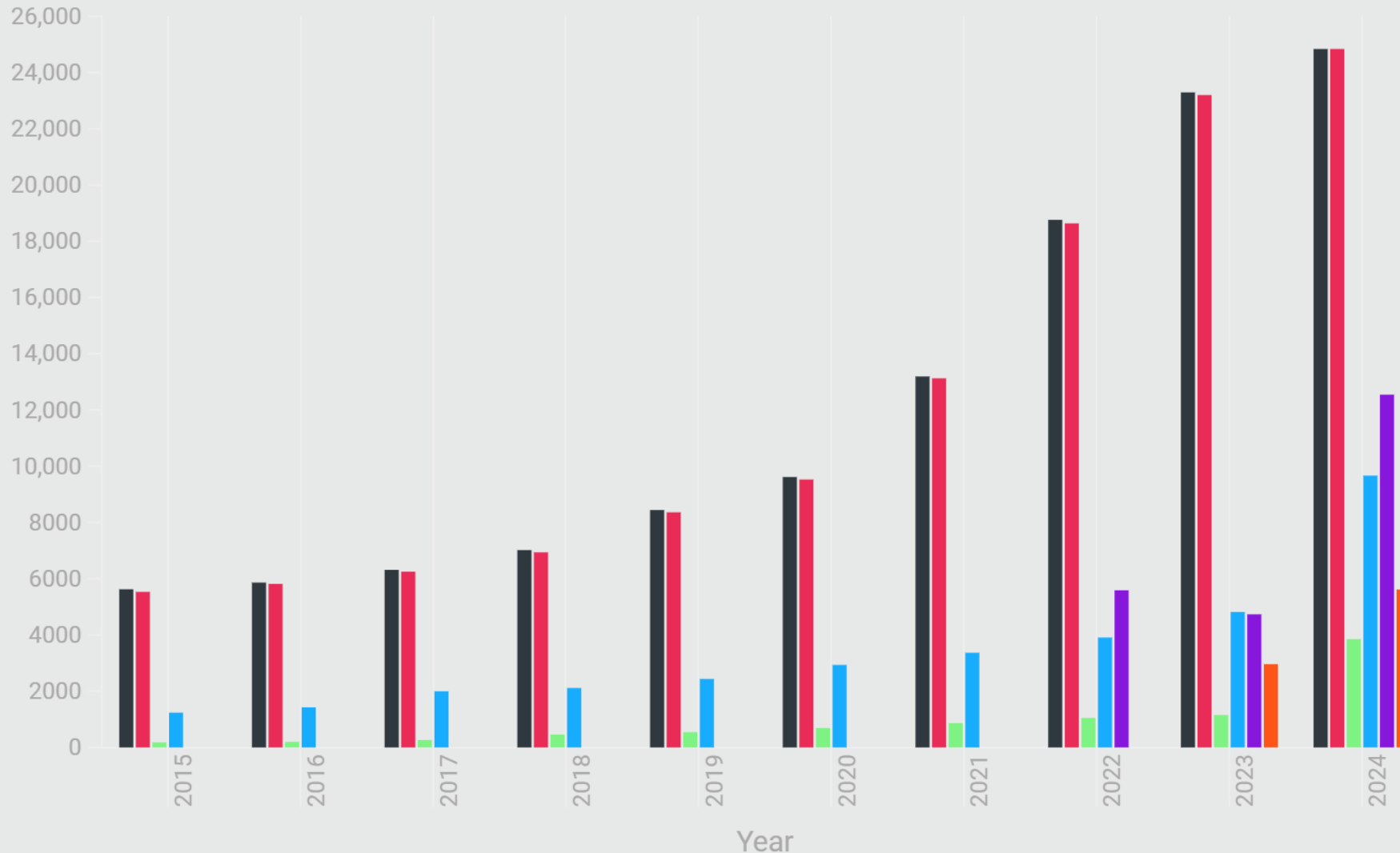

# The impact of supply chain disclosure

Supply chains naturally create a domino effect of environmental impacts on a large scale - something that you as a supplier can collectively be part of.



Companies that disclose through CDP may reduce direct emissions by **7-10%** within just 2 years – demonstrating that disclosure is not just another tick box exercise.



Year on year, CDP disclosers are more likely to take environmental action with **69%** of third-time disclosers having emissions reduction initiatives, compared to 38% with first-time disclosers.

# CDP's alignment with IFRS S2

**All companies** disclosing through CDP will be disclosing against the IFRS S2 standard for climate-related disclosure.

In 2024, **CDP delivered the first S2-aligned dataset** to the market.



Relevant questions will be tagged and detailed mapping will soon be available on CDP's website.



CDP's questionnaire provides an effective tool to support companies on their path to ISSB compliance.



CDP is developing data tools to support post-disclosure analysis for organizations and data users.



CDP continues to build on the baseline to enable the most ambitious environmental disclosure.



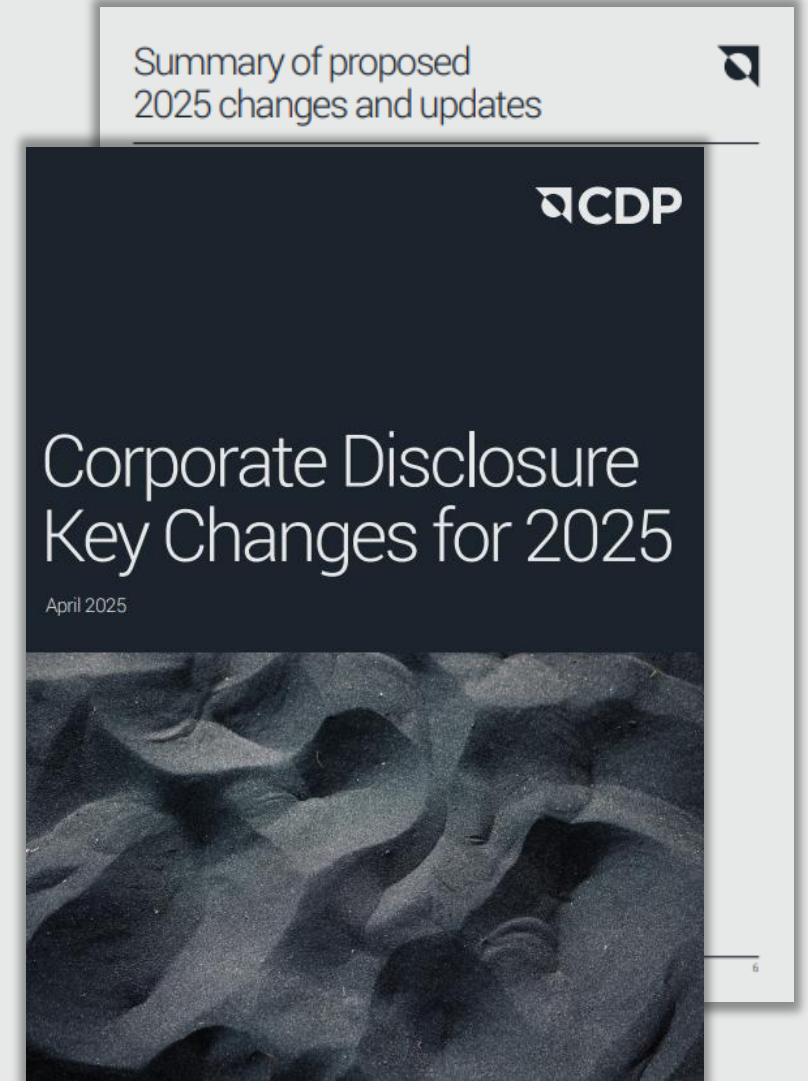


# Corporate Disclosure Key Changes for 2025

Following the structural changes and framework alignments introduced in 2024, the 2025 questionnaire maintains a streamlined approach, with **only minor refinements aimed at improving clarity and usability**. The majority of datapoints remain consistent, ensuring continuity for organizations. CDP's scoring methodology is also stable with only small changes planned and improvements for consistency.

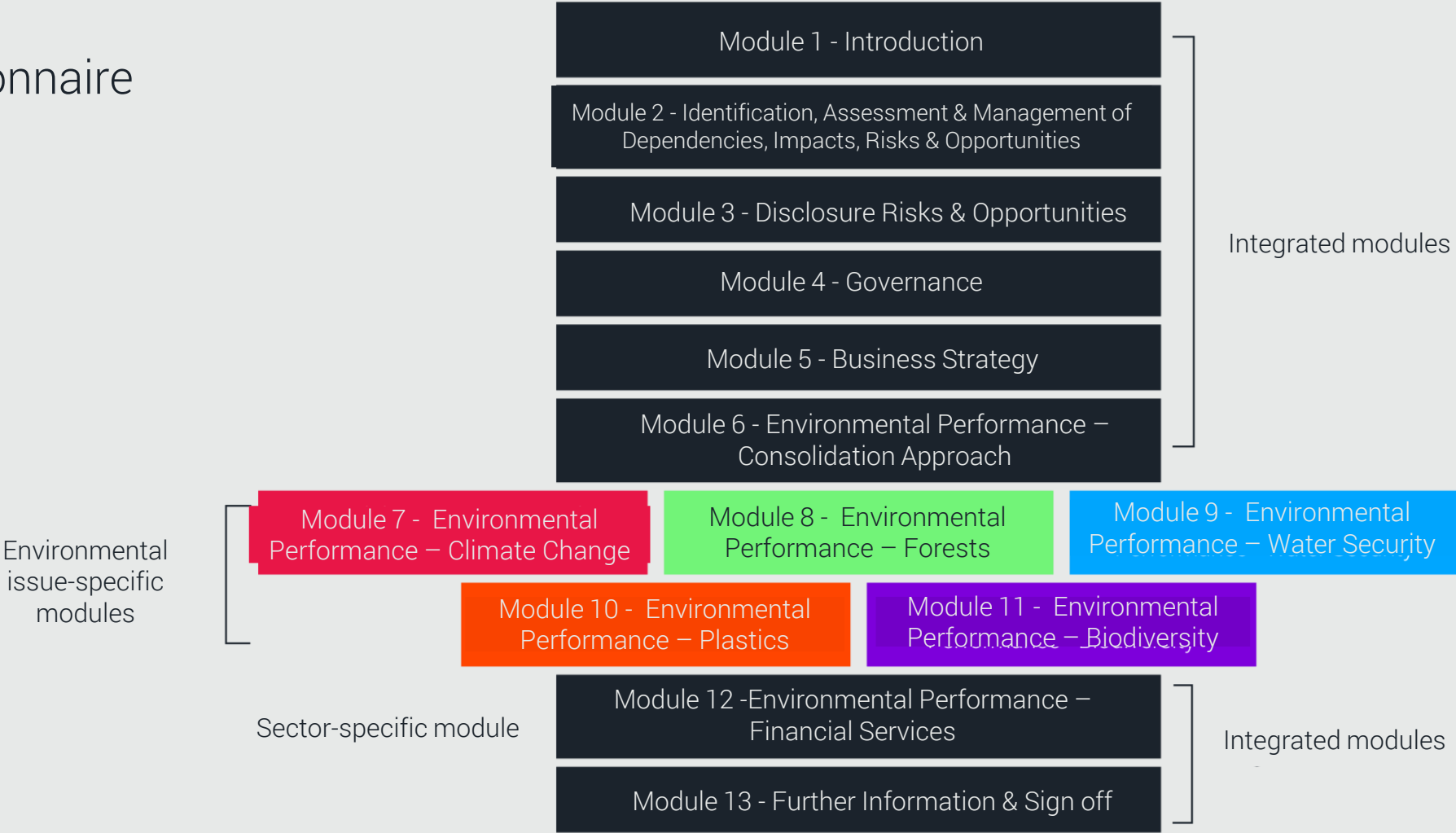

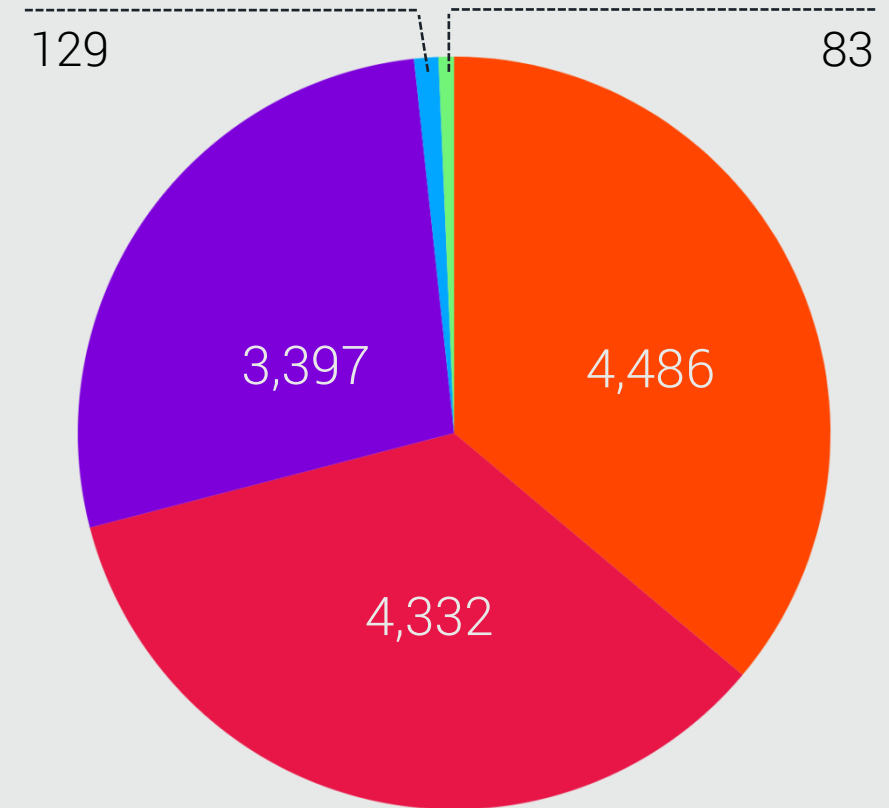
# SME questionnaire:

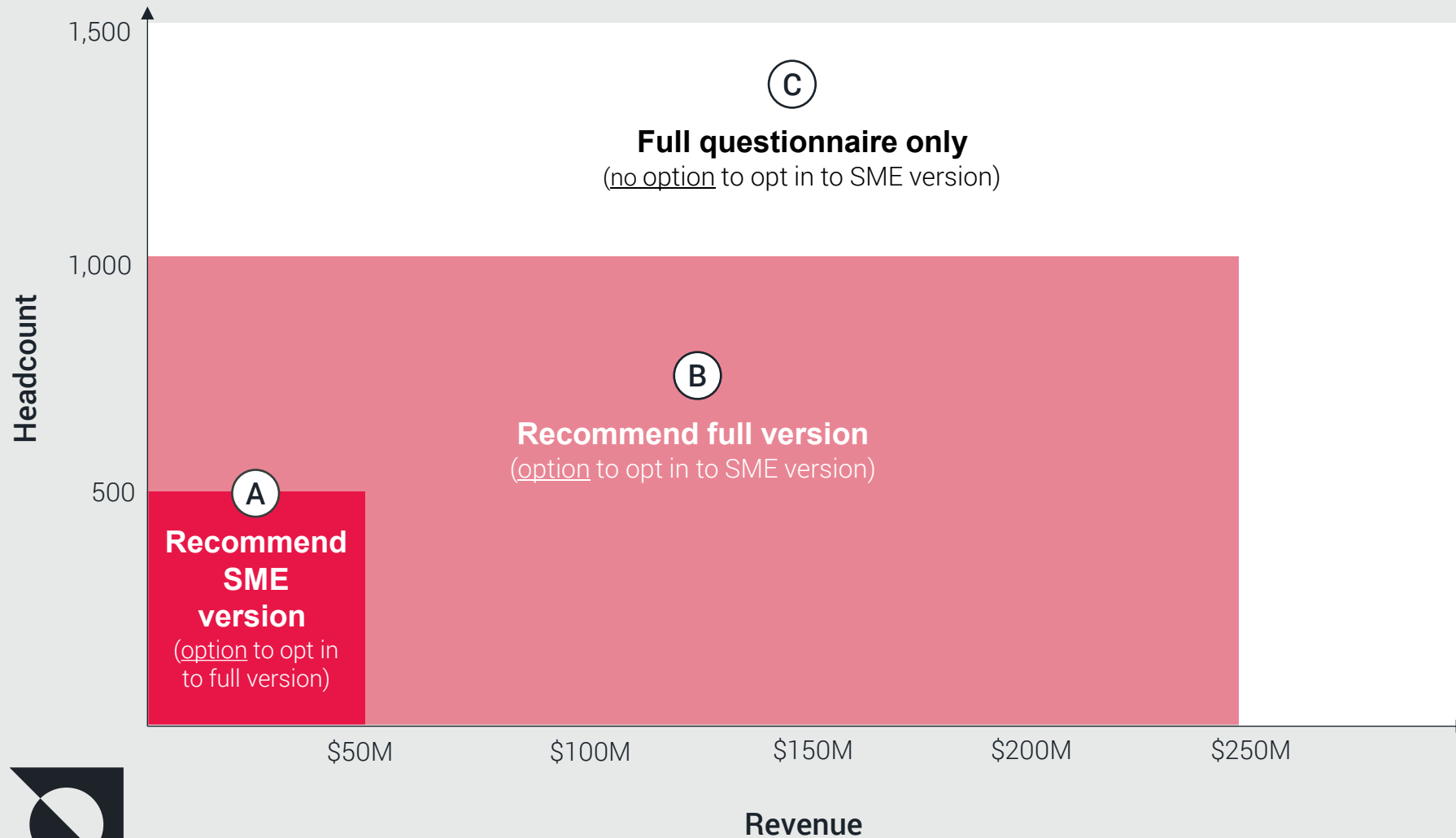

# SME criteria and options for disclosure



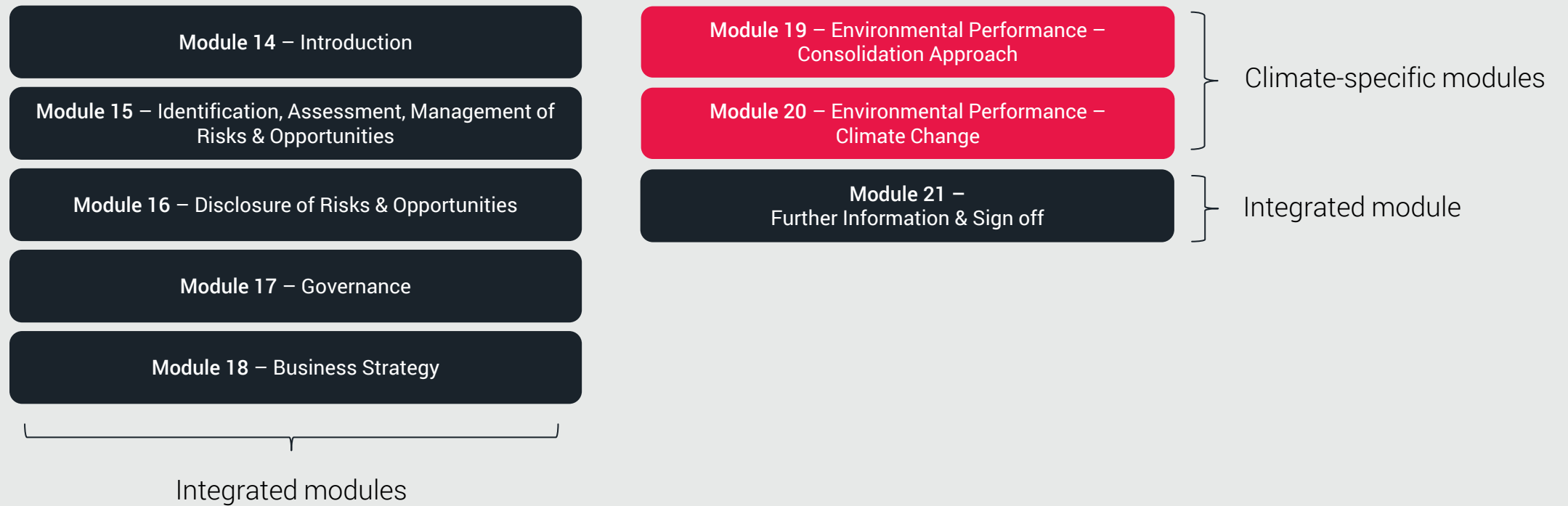
## Thresholds:

- A** **SME recommended (option to opt to full):** IF headcount <500 AND revenue <US\$50 million
- B** **Full recommended (option to opt to SME):** IF headcount <500 AND revenue 50M> US\$250 million, OR IF headcount 500-1,000 AND revenue < US\$250 million
- C** **Full (no option to opt to SME):** IF headcount >1,000 OR revenue >US\$250 million

This question asks whether companies have assessed their forests and/or water dependencies, impacts, risks and opportunities. If so, forests/water data points may also be relevant to your organization.

# Questionnaire set-up questions

## Intent to submit (on forests/water security)

Whether you are requested to disclose following an authority request or following CDP's industry impact classification or your own self-assessment, you can either accept or decline to respond. If you are eligible for scoring and decline, this may affect your CDP score.

Note that companies can still opt-in to respond to forests or water on a voluntary basis. If you choose to decline in this case this will not impact your score.

If your organization intends to submit through the forests route, they will also select which forests commodities they produce or source and whether they intend to disclose on these.

Finally, if relevant, your organization confirms if they have any mining activities or run mining projects, in which case they will be presented with the mines biodiversity route (previously the forests mining questionnaire).

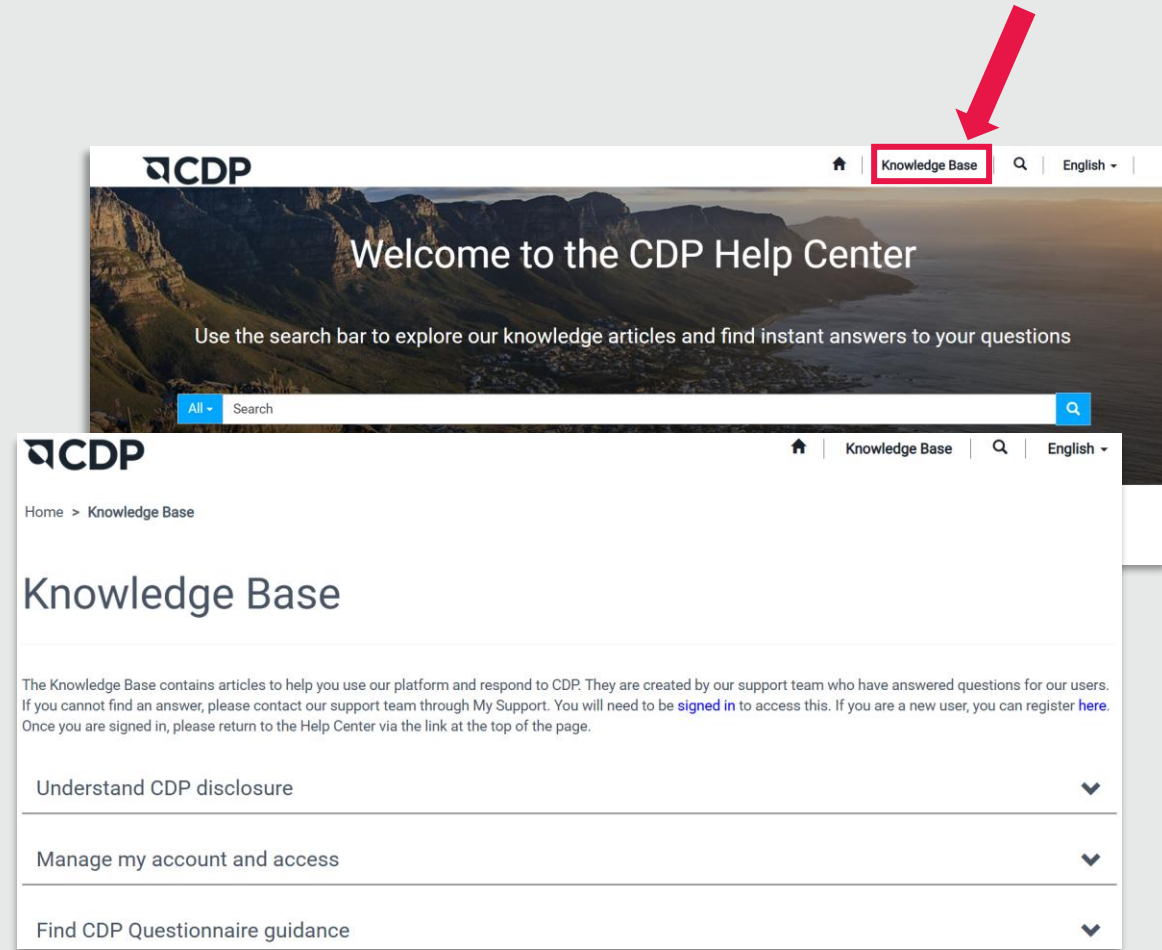

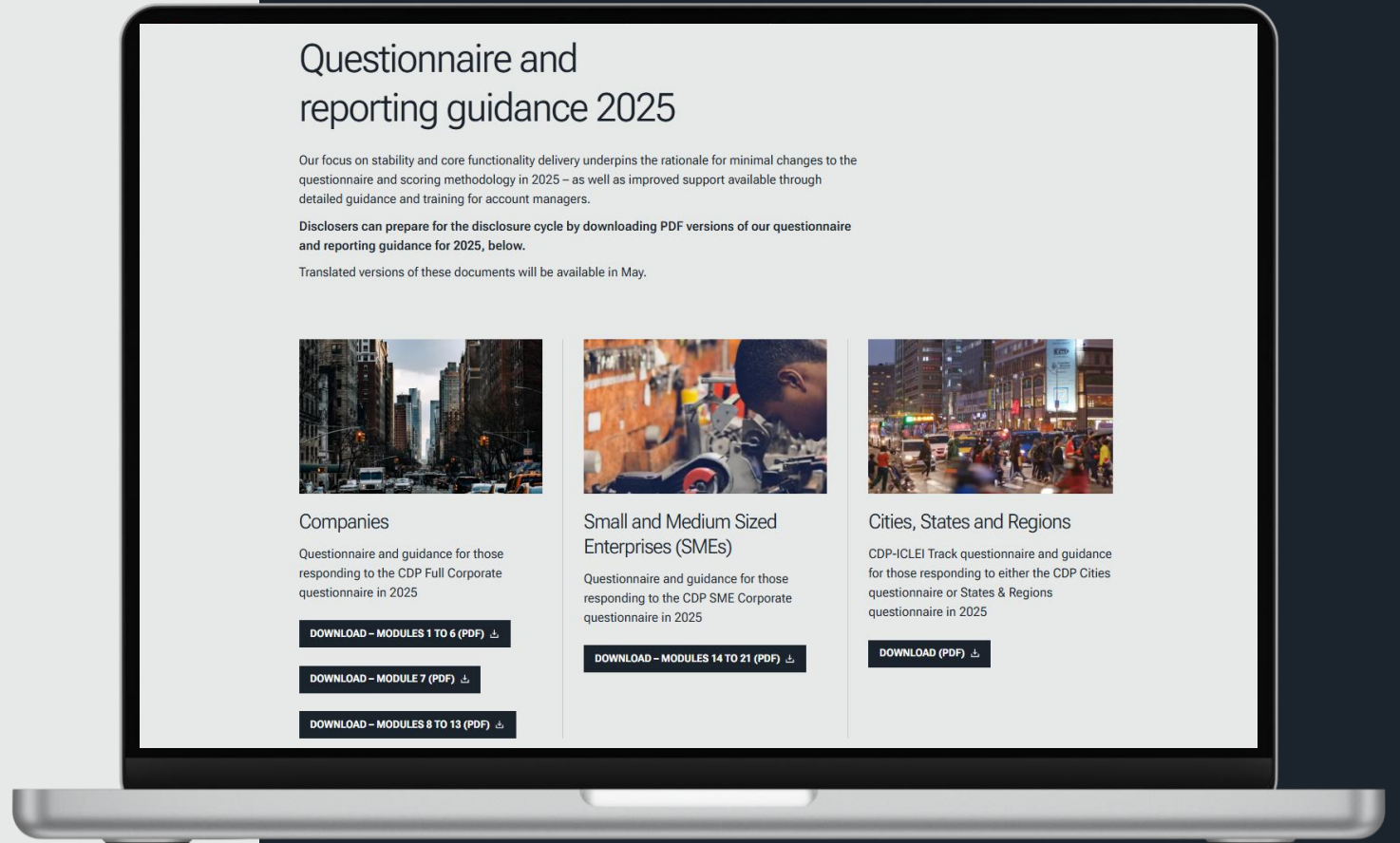

- **What if I can't respond to the full questionnaire?**
  - CDP always encourages suppliers to submit a partial response instead of none at all.
  - Focus on the specific target questions put forward by your customers to reduce reporting burden.
  - Perfection is not expected in your first response, do your best.
- **Do I have to pay the CDP admin fee?**
  - In 2025, suppliers do not need to pay a fee to respond to a request(s) from **ONLY** Customer(s).
  - You will need to pay the admin fee if you are ALSO requested to disclose by CDP's Capital Market Signatories

# Frequently Asked Questions

- **What if I'm based in a non-English speaking country? Can CDP still support me?**

- **I'm concerned about data protection and confidentiality**
  - Data and information reported in Supply Chain questions are assigned specifically to the requesting company. No other company has access to that information.
  - Supplier scores are never publicly shared regardless of public/non-public submissions if only responding to customer request(s).
