Introduction

This document details the 2025 CDP SME scoring methodology for climate change and should be used in conjunction with CDP's SME corporate questionnaire & reporting guidance for 2025, as well as CDP's SME scoring introduction and other scoring documentation. It is strongly recommended to familiarize yourself with the contents of both the 2025 SME corporate questionnaire and reporting guidance before using the scoring methodology. Question dependencies will be detailed in these supplementary documents to inform companies which questions they are eligible to be scored for.

This document provides the scoring criteria and points available for each question in CDP's 2025 SME corporate questionnaire. Through this questionnaire, organizations can provide data on multiple environmental issues in a single disclosure, encouraging more holistic and balanced reporting.

SME scoring in 2025

The SME corporate questionnaire is tailored to the needs of SMEs and contains fewer and simplified datapoints. Only organizations that meet CDP's SME eligibility thresholds will have the option to complete the SME corporate questionnaire. For 2025 there is a focus on climate change, with inclusion of integrated forests and water security datapoints to kickstart disclosure journey for these environmental issues. Although the SME corporate questionnaire mainly focuses on climate change in 2025, we encourage CDP disclosers and data users to assess and manage environmental risks and opportunities as an interrelated challenge. As with 2024, the 2025 SME corporate questionnaire is only scored for climate change; forests and water security are not scored.

There are 8 modules in the SME corporate questionnaire (labelled modules 14 to 21). Modules 14 to 19, and 21 are integrated, which means that questions in these modules cover more than one environmental issue area. Module 20 is specific to the climate change environmental issue area. Unlike the full corporate questionnaire, organizations responding to the SME corporate questionnaire will not be presented with sector-specific datapoints.

Each question is tagged to one or more of the three environmental issue areas, listed under the question text. The following notations have been used in this document to denote environmental issue areas (Table 1). In 2025, SME is only scored for climate change; therefore, scoring for questions tagged to multiple environmental issues will still be tailored to the climate change issue area.
