Position Function:

Under the direction and supervision of the Water Operations Manager, LRWRS Operations Superintendent or Senior Water/Wastewater, and working as part of a team, assists with the performance of duties necessary to operate and maintain equipment in the water treatment plants, water reclamation plants, water transmission systems and wastewater collection systems with a primary focus on transmission and collection systems operation and maintenance. May work varying shifts, hours or locations to become proficient in all aspects of the water and wastewater systems.

Typical/Essential Duties:

- Coordinates and assists with performing preventative and minor corrective maintenance on transmission and collection system facilities, equipment and appurtenances, to include operating valves, repairing and replacing parts, line locating, and GPS data collection. Provides inspection of work completed by other District personnel or contracted vendors and supports UTRWD Construction projects as needed.
- 2) Performs daily visual inspections of transmission or collection systems to ensure adequate monitoring and maintenance of system pipelines, pump stations, lift stations, meter vaults and stations, valves, and other related facilities, equipment and appurtenances. Duties include collecting data, completing checklists, and preparing daily inspections reports.
- Performs duties as necessary to ensure compliance with transmission system water quality testing and analysis, to include collecting daily and quarterly water samples, performing water quality analysis, and preparing reports as required.
- 4) Performs scheduled monthly and non-routine meter readings of all meters.
- 5) Provides support to plant operations when needed up to and including temporary assignments of operating water and wastewater treatment facilities.
- 6) Performs additional duties as assigned.

Knowledge, Skills, and Abilities:

Must possess a High School Diploma or GED equivalent. At least four (4) years of direct or very similar work related experience as a Water or Wastewater Treatment Plant Operator, Transmission/Distribution Operator, Collections Operator or similar position is required. Must possess a TCEQ Class 'B' Surface Water Treatment License, TCEQ Class 'B' Water Distribution License, or TCEQ Class 'B' Wastewater Treatment License or higher. Dual certification in water and wastewater preferred. Experience with GIS and GPS equipment, as well as line locating equipment is a plus. Must be able to read and comprehend technical information, construction documents and drawings, directives, maintenance manuals, memos, reports and other job related materials.

Works requires the ability to be able to communicate effectively, both orally and in writing. Must display general computer competency with understanding of SCADA, MS Word and Excel. Other computer skills and experience with other HMl's are a plus.

Must be able to perform general math calculations, to include calculating dosages, volumes, square feet, linear feet, and other job related calculations. Must have valid Class C Texas Driver's License.. Must be able to pass applicable pre-employment Drug Screen, Physical, and Background Checks.
