### Woods Access guidance regarding Covid-19

• **Anyone that has been in contact with someone who has, or is suspected as having, Covid-19 must not attend the woods.**

**We recommend that anyone that has vulnerable people living at home should not attend the woods.**

- A risk assessment for the safe access to our woods at this time has been prepared and is attached.
- Our landowner had seen the NFAS guidelines and our RA and has agreed with members starting to use the woods between the hours of 12:00 midday and 7:00pm under the following stipulations.
  - No more than two people observing social distancing, to shoot round together.
  - When social distancing, approach the target one at a time, pull own arrows, then stand 2 metres away to allow the other person to pull their arrows. Try not to touch the target with your hands. Be aware when searching for arrows.
  - Targets out on the course that need to be re-set or replaced should be handled with gloves and wiped down with sanitizer.
  - Communal facilities at woods are unavailable, such as lighting fires, club hut, storage sheds, toilets etc.
  - Members must not invite guests.
  - Our next open Shoot in August is cancelled.

In addition to the above, members must observe and apply the requirements in our Risk Assessment regarding use of sanitizers when handling the access gates / locks / keypads.

Club members	Shooting together / touching gates, targets, arrows not their own.	Accidental less than 2M contact. Un-gloved contact with gates, targets, arrows.
Landowner / family	Contact with gates. Unexpected meeting with members.	Un-gloved contact with gates. Accidental less than 2M contact.
Stables staff / riders	Contact with gates. Unexpected meeting with members.	Un-gloved contact with gates. Accidental less than 2M contact.

5	Accidental less than 2M contact with others – Landowner & family, Stables staff & riders..	MCFA club members. Landowner & Family. Stables staff & riders.	1	3	3	Face covering MUST be used. Only shoot at times pre-arranged with the landowner to avoid meeting. If accidentally meeting someone not from the club, keep AT LEAST 2M away whilst negotiating passing. If passing is not possible, re-track to a safe place.	1	3	1
