# **UKI Orthodontic Summit Awards Evening 2022**

### **Rules & Regulations**

# **AWARD TITLE: MOST INSPIRATIONAL TEEN CASE**

- This award aims to recognise an inspirational teen case which has been completed using the Invisalign system.
- The case must have been completed between 1st January 2021 to 31st December 2021.
- The award-winning case will show a significant transformation in a teen patient's smile, from a clinical perspective, which has positively impacted their life as a result of treatment using the Invisalign system.
- Inclusive of patient images of the Invisalign treatment journey, the submission will
  highlight the key challenges and how they were overcome, as well as explaining
  why the methods undertaken were the most effective way to tackle them.
- The submission should demonstrate substantial progress throughout the treatment journey and explain how this case inspires others to utilise the Invisalign system within their practice.
- This award aligns perfectly with our objective to 'Build a bigger, better and bolder business with the Invisalign system'.

## **ELIGIBILITY**

- To be eligible for the award, submissions must include images of the patient throughout their Invisalign treatment journey (before, during and after images), along with a full description of why you believe this teen case is inspirational to other Orthodontists treating patients using the Invisalign system.
- Entries must be in the English language.
- The patient in question and their parent/ legal guardian **must give consent** for these images to be used as part of the submission. More information on this, including the agreement to consent, is stated within the submission forms.
- Failure to submit your case images as part of your entry will lead to your submission being withdrawn.
- The case submission must have been completed by the clinician in question, under the account listed on the submission form.
- If you submit your cases under another account, you must specify which account
  this is when submitting your entry. The case must have been completed under
  stated account.
- To be considered a teen case, the patient must have been within the specified age group at the beginning of the treatment (12-18 years).
- The treatment must have been completed between 1<sup>st</sup> January 2021- 31<sup>st</sup> December 2021.

#### **ENTRY & JUDGING PROCESS**

- Once a submission has been made, it cannot be edited or withdrawn and will still be considered for the award.
- Award organisers shall not be responsible for any submissions that are lost, mislaid, or delayed.
- All submissions must be made digitally following the stated process.

## **JUDGING PROCESS**

- All submissions will be judged and shortlisted by our Align team, who will then bring forward 3 submissions for the finalised shortlist.
- Once the shortlist is decided, a panel consisting of UKI Ortho Advisory Board members will decide on the overall winner from the 3 submissions.
- The shortlist will be announced ahead of the awards ceremony.
- On approaching the judging process, each submission will be anonymous to ensure fair and accurate judgement at all stages.
- Only one overall winner will be awarded.
- The winner of the 'Most Inspirational Teen Case' award will receive a plaque and a framed certificate. This will be presented to the winner on the evening of the awards ceremony.

#### By entering a submission you:

## **RULES**

On submitting your case, you must read and adhere to the following:

- Ensure that the case you have submitted was completed within the specified dates (1st January- 31st December 2021).
- You must have patient and parent/ legal guardian consent to use their images for the submission and in any other publication post-event.
- The case you have submitted must be one of your own treatments, thus, you are the treating clinician.
- You may not submit on behalf of another doctor.
- The maximum number of submissions for this award is 2 per doctor.
- You must only submit a TEEN CASE (12-18 years) for this award.
