CMC MARKETS - PRIZE DRAW - EVERTON SEASON TICKET TERMS & CONDITIONS

Introduction

1. These terms and conditions ("**Terms**") form the basis of the offer to participate in the CMC Markets Everton Season Ticket 2026/27 prize draw ("**the Prize Draw**").
2. Taking part in this Prize Draw constitutes acceptance of these Terms. CMC Markets UK plc (company registration number 02448409) ("**CMC Markets**") is the provider of this Prize Draw. CMC Markets reserves the right to vary or cancel these Terms where reasonably necessary to do so, subject to applicable law.

Offer Period

3. The Prize Draw is open from 9:00am BST on Monday 20 July 2026 and will close at 11:59pm BST on Sunday 26 July 2026 ("**Promotion Period**").

Conditions of Eligibility

4. The Prize Draw is open to UK residents aged 18 years or older ("**Eligible Entrant**").
5. Employees of CMC Markets or any other company within its group are not eligible to enter this Prize Draw.
6. To be eligible to be selected as a Winner (as defined below), an Eligible Entrant must, during the Promotion Period:
 - (a) provide a full and complete response to the CMC Markets survey ("**Response**") and submit their Response to CMC Markets via a CMC Markets nominated survey website (a link to the survey website will be provided via an email from CMC Markets); and
 - (b) complete all requested details including but not limited to the Response, their name, phone number and email address.
7. The Prize Draw is limited to one Response per Eligible Entrant.
8. Entries that are incomplete, illegible, corrupted, altered or otherwise fail to comply with these Terms may be disqualified. Only one (1) entry is permitted per Eligible Entrant. Where multiple entries are received from the same Eligible Entrant, only the first valid entry received during the Promotion Period will be entered into the Prize Draw and all subsequent entries may be disregarded. Entries submitted by automated means, generated by computer, completed by third parties, made in bulk or otherwise not submitted personally by the Eligible Entrant are prohibited and may be disqualified.

The Prize Draw & Prize

9. Following the expiry of the Promotion Period, all Eligible Entrants will be entered into a random draw, and two (2) winners will be selected by CMC Markets at random from all valid eligible entries by an independently supervised random selection process or by a verifiable random computer process during the Promotion Period ("**Winners**") to receive:
 - (a) one (1) Winner will receive two (2) Everton Men's Season Tickets for the 2026/27 season; and
 - (b) one (1) Winner will receive two (2) Everton Women's Season Tickets for the 2026/27 season(the "**Prize**").
10. The Prize is subject to any applicable ticketing terms and conditions, stadium regulations and other policies imposed by Everton Football Club from time to time. The Winners are responsible for complying with such

terms, conditions and regulations. CMC Markets accepts no responsibility or liability for any act or omission of Everton Football Club or for any changes to, suspension or withdrawal of the Prize resulting from the application of such terms, conditions or regulations.

11. CMC Markets' decision in relation to any aspect of the Prize Draw will be final and binding on every Eligible Entrant.
12. Winners will be notified by email within fourteen (14) days following the expiry of the Promotion Period and must claim their Prize within five (5) calendar days of notification. If a Winner fails to claim their Prize within five (5) calendar days of notification, then CMC Markets reserves the right to select a reserve Winner in accordance with the original random draw process.
13. The Prize will be issued in the name of the Winner, and the Winner may not transfer or assign the Prize, including to friends or family members.
14. The Winner may be asked (but is not obliged) to participate in reasonable publicity, subject to the Winner's consent where required.
15. CMC Markets reserves the right to verify the eligibility of any entrant or Winner, including by requesting proof of identity, age or residency. Failure to provide any information reasonably requested within the time specified may result in disqualification and the selection of an alternative Winner.
16. CMC Markets reserves the right to substitute the Prize with a prize of equal or greater value, where reasonably practicable, if the Prize becomes unavailable due to circumstances beyond CMC Markets' reasonable control, including where it is cancelled, postponed, withdrawn or amended by Everton Football Club or any other third party.
17. This Prize Draw is non-exchangeable, non-transferable, and is not redeemable for other prizes.

Legal

18. CMC Markets will not accept any liability for lost, late, incomplete, illegible, or misdirected entries to the fullest extent permitted by law.
19. CMC Markets will be collecting personal information from all participants to facilitate the Prize Draw. If the information requested by CMC Markets is not provided, the participant will not be eligible to participate in the Prize Draw. By taking part in this Prize Draw, personal information of participants will be processed for the purposes of administering the Prize Draw in accordance with CMC Markets' Privacy Policy. CMC Markets will share the personal information of Winners with Everton Football Club solely for the purpose of verifying eligibility and administering the Prize. Any information collected from participants in the Prize Draw is subject to CMC Markets' Privacy Policy and will be handled in accordance with the applicable laws of England & Wales.
20. Subject to applicable data protection law, the surname and county of the Winners may be made available on request. Any request must be made within 30 days of the closing date by contacting ticketing@cmcmarkets.com. Winners may object to or limit disclosure where they have legitimate grounds.

If for any reason the Prize Draw cannot be run as planned due to circumstances including, but not limited to, infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the reasonable control of CMC Markets which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Prize Draw, CMC Markets reserves

the right (subject to applicable law) to cancel, terminate, modify or suspend the Prize Draw and, where appropriate, to select Winners from eligible entries received prior to the relevant event.

22. CMC Markets also reserves the right to disqualify any person who tampers with the entry process, acts fraudulently or in breach of these Terms, or otherwise seeks to undermine the legitimate operation of the Prize Draw.
23. These Terms and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with them or the Prize Draw shall be governed by and construed in accordance with the laws of England and Wales. The courts of England and Wales shall have exclusive jurisdiction to settle any such dispute or claim.
